## AN ACT

- 1 Amending the act of November 24, 1998 (P.L.874, No.110),
- 2 entitled "An act relating to the unlawful disposition of
- 3 motor vehicles; and providing penalties, "further providing
- 4 for the definition of "chop shop."
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 2 of the act of November 24, 1998
- 8 (P.L.874, No.110), known as the Motor Vehicle Chop Shop and
- 9 Illegally Obtained and Altered Property Act, is amended to read:
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Chop shop." Any building, lot or other premises where one
- 15 or more persons engage in altering, destroying, disassembling,
- 16 dismantling, reassembling, storing or possessing any motor
- 17 vehicle or motor vehicle part known [by such person or persons
- 18 to be illegally obtained] to be illegally obtained by theft,

- 1 fraud or conspiracy to defraud in order to either:
- 2 (1) alter, counterfeit, deface, destroy, disguise,
- 3 falsify, forge, obliterate or remove the identification,
- 4 including the vehicle identification number of the motor
- 5 vehicle or motor vehicle part, in order to misrepresent the
- 6 identity of the motor vehicle or motor vehicle part or to
- 7 prevent the identification of the motor vehicle or motor
- 8 vehicle part; or
- 9 (2) sell or dispose of the motor vehicle or motor
- 10 vehicle part.
- 11 "Motor vehicle." A vehicle which is self-propelled except
- 12 one which is propelled solely by human power or by electric
- 13 power obtained from overhead trolley wires but not operated upon
- 14 rails.
- 15 "Person." A natural person, firm, copartnership, association
- 16 or corporation.
- 17 "Vehicle identification number." A combination of numerals
- 18 or letters, or both, which the manufacturer assigns to a vehicle
- 19 for identification purposes or, in the absence of a manufacturer
- 20 assigned number, which the Department of Transportation assigns
- 21 to a vehicle for identification purposes.
- 22 Section 2. This act shall take effect in 60 days.
