AN ACT

- Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An act relating to insurance; amending, revising, and consolidating the law providing for the incorporation of 3 insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds 6 associations, reciprocal and inter-insurance exchanges, and 7 fire insurance rating bureaus, and the regulation and 8 supervision of insurance carried by such companies, associations, and exchanges, including insurance carried by the State Workmen's Insurance Fund; providing penalties; and 10 11 repealing existing laws, " mandating health insurance coverage 12 for colorectal cancer screening.
- 13 The General Assembly of the Commonwealth of Pennsylvania
- 14 hereby enacts as follows:
- 15 Section 1. The act of May 17, 1921 (P.L.682, No.284), known
- 16 as The Insurance Company Law of 1921, is amended by adding a
- 17 section to read:
- 18 Section 635.2. Coverage for Colorectal Cancer Screening.--
- 19 (a) Except to the extent already covered under another policy,

- 1 all health insurance policies as defined in this section shall
- 2 <u>also provide coverage for colorectal cancer screening for</u>
- 3 covered individuals in accordance with the most recently
- 4 published American Cancer Society guidelines for colorectal
- 5 <u>cancer screening and consistent with approved medical standards</u>
- 6 and practices.
- 7 (1) Coverage for nonsymptomatic covered individuals who are
- 8 fifty (50) years of age or older shall include, but not be
- 9 limited to:
- 10 (i) an annual fecal occult blood test;
- 11 (ii) a sigmoidoscopy or a test consistent with approved
- 12 medical standards and practices to detect colon cancer, at least
- 13 <u>once every four (4) years.</u>
- 14 (iii) A colonoscopy at least once every ten (10) years.
- (2) Coverage for symptomatic covered individuals who are
- 16 <u>less than fifty (50) years of age shall include a colonoscopy,</u>
- 17 sigmoidoscopy or any combination of colorectal cancer screening
- 18 tests at a frequency determined by a physician.
- 19 (b) The coverage required under this section shall be
- 20 subject to annual deductibles, coinsurance and copayment
- 21 requirements imposed by an entity subject to this section for
- 22 similar coverages under the same health insurance policy or
- 23 contract.
- 24 (c) For the purpose of this section:
- 25 (1) "Health insurance policy" means any individual or group
- 26 <u>health</u>, <u>sickness or accident policy or subscriber contract or</u>
- 27 certificate issued by an entity subject to any one of the
- 28 following:
- 29 (<u>i</u>) This act.
- 30 (ii) The act of December 29, 1972 (P.L.1701, No.364), known

- 1 as the "Health Maintenance Organization Act."
- 2 (iii) The act of May 18, 1976 (P.L.123, No.54), known as the
- 3 "Individual Accident and Sickness Insurance Minimum Standards
- 4 Act."
- 5 (iv) Article XXIV, relating to fraternal benefit societies.
- 6 (v) 40 Pa.C.S. Ch. 61 (relating to hospital plan
- 7 <u>corporations</u>) or 63 (relating to professional health services
- 8 plan corporations).
- 9 <u>(vi) Medical assistance.</u>
- 10 The term does not include accident only, fixed indemnity,
- 11 <u>limited benefit, credit, dental, vision, specified disease,</u>
- 12 Medicare supplement, Civilian Health and Medical Program of the
- 13 <u>Uniformed Services (CHAMPUS) supplement, long-term care or</u>
- 14 disability income, workers' compensation or automobile medical
- 15 payment insurance.
- 16 (2) "Colonoscopy" means an examination of the rectum and the
- 17 entire colon using a lighted instrument called a colonoscope.
- 18 (3) "Colorectal cancer screening" means any of the following
- 19 procedures that are furnished to an individual for the purpose
- 20 <u>of early detection of colorectal cancer:</u>
- 21 (i) Screening fecal-occult blood test.
- 22 (ii) Screening flexible sigmoidoscopy.
- 23 (iii) Screening colonoscopy.
- 24 <u>(iv) Screening barium enema.</u>
- 25 (4) "Symptomatic person" means one of the following:
- 26 (i) an individual who experiences a change in bowel habits,
- 27 rectal bleeding or persistent stomach cramps, weight loss,
- 28 <u>abdominal pain; or</u>
- 29 <u>(ii) an individual who poses a higher than average risk for</u>
- 30 <u>colorectal cancer because he or she has had colorectal cancer or</u>

- 1 polyps, inflammatory bowel disease or an immediate family
- 2 <u>history of such conditions.</u>
- 3 Section 2. This act shall take effect in 60 days.
