AN ACT

- Amending the act of June 3, 1937 (P.L.1333, No.320), entitled 2 "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 3 4 primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; 7 imposing penalties for violation of the act, and codifying, 8 revising and consolidating the laws relating thereto; and 9 10 repealing certain acts and parts of acts relating to elections, "further providing for absentee electors files and 11 12 lists. 13 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 14 Section 1. Section 1302.3 of the act of June 3, 1937 15 (P.L.1333, No.320), known as the Pennsylvania Election Code,

- 19 Section 1302.3. Absentee Electors Files and Lists.--(a) The
- 20 county board of elections shall maintain at its office a file
- 21 containing the duplicate absentee voter's temporary registration

- 1 cards of every registered elector to whom an absentee ballot has
- 2 been sent. Such duplicate absentee voter's temporary
- 3 registration cards shall be filed by election districts and
- 4 within each election district in exact alphabetical order and
- 5 indexed. The registration cards so filed shall constitute the
- 6 Registered Absentee Voters File for the Primary or Election of
- 7 (date of primary or election) and shall be kept on file for a
- 8 period commencing the Tuesday prior to the day of the primary or
- 9 election until the day following the primary or election or the
- 10 day the county board of elections certifies the returns of the
- 11 primary or election, whichever date is later. Such file shall be
- 12 open to public inspection at all times subject to reasonable
- 13 safeguards, rules and regulations[.], including requiring any
- 14 <u>individual who asks to inspect the file to identify himself, and</u>
- 15 present identification that includes a photograph and signature,
- 16 by signing his name and printing his name and address on a form
- 17 prepared by the county board. The county board of elections
- 18 shall post in a conspicuous public place at its office a sign
- 19 stating that the file is open to public inspection upon
- 20 completion of the form.
- 21 (b) The county board of elections shall [post in a
- 22 conspicuous public place] maintain at its office a master list
- 23 arranged in alphabetical order by election districts setting
- 24 forth the name and residence, and at primaries, the party
- 25 enrollment, of (1) every military elector to whom an absentee
- 26 ballot is being sent, each such name to be prefixed with an "M";
- 27 (2) every bedridden or hospitalized veteran outside the county
- 28 of his residence who is not registered and to whom an absentee
- 29 ballot is being sent, each such name to be prefixed with a "V";
- 30 and (3) every registered elector who has filed his application

- 1 for an absentee ballot too late for the extraction of his
- 2 original registration card and to whom a ballot is being sent
- 3 and every qualified elector who has filed his application for an
- 4 absentee ballot and is entitled, under provisions of the
- 5 Permanent Registration Law as now or hereinafter enacted by the
- 6 General Assembly, to absentee registration prior to or
- 7 concurrently with the time of voting, each such name to be
- 8 prefixed with a "C." This list shall be known as the Military,
- 9 Veterans and Emergency Civilians Absentee Voters File for the
- 10 Primary or Election of (date of primary or election) [and shall
- 11 be posted for a period commencing the Tuesday prior to the day
- 12 of the primary or election until the day following the primary
- 13 or election or the day on which the county board of elections
- 14 certifies the returns of the primary or election, whichever date
- 15 is later]. Such [file] <u>list</u> shall be open to public inspection
- 16 at all times subject to reasonable safeguards, rules and
- 17 regulations[.], including requiring any individual who asks to
- 18 inspect the list to identify himself, and present identification
- 19 that includes a photograph and signature, by signing his name
- 20 and printing his name and address on a form prepared by the
- 21 county board. The county board of elections shall post in a
- 22 conspicuous public place at its office a sign stating that the
- 23 <u>list is open to public inspection upon completion of the form.</u>
- 24 This [posted] list shall not contain any military address or
- 25 references to any military organization. Upon written request,
- 26 the county board shall furnish a copy of such list to any
- 27 candidate or party county chairman.
- 28 (c) Not less than five days preceding the election, the chief
- 29 clerk shall prepare a list for each election district showing
- 30 the names and post office addresses of all voting residents

- 1 thereof to whom official absentee ballots shall have been
- 2 issued. Each such list shall be prepared in duplicate, shall be
- 3 headed "Persons in (give identity of election district) to whom
- 4 absentee ballots have been issued for the election of (date of
- 5 election), " and shall be signed by him not less than four days
- 6 preceding the election. He shall [post the original of each such
- 7 list in a conspicuous place] maintain the original of each list
- 8 in the office of the county election board [and see that it is
- 9 kept so posted until the close of the polls on election day].
- 10 Each list shall be open to public inspection at all times
- 11 <u>subject to reasonable safeguards, rules and regulations,</u>
- 12 including requiring any individual who asks to inspect a list to
- 13 <u>identify himself</u>, and present identification that includes a
- 14 photograph and signature, by signing his name and printing his
- 15 name and address on a form prepared by the county board. The
- 16 <u>chief clerk shall post in a conspicuous public place in the</u>
- 17 office of the county election board a sign stating that the list
- 18 <u>is open to public inspection upon completion of the form. Upon</u>
- 19 written request, the chief clerk shall furnish a copy of such
- 20 list to any candidate or party county chairman. He shall cause
- 21 the duplicate of each such list to be delivered to the judge of
- 22 election in the election district in the same manner and at the
- 23 same time as are provided in this act for the delivery of other
- 24 election supplies, and it shall be the duty of such judge of
- 25 election to [post] maintain such duplicate list [in a
- 26 conspicuous place] within the polling place of his district [and
- 27 see that it is kept so posted] throughout the time that the
- 28 polls are open. [Upon written request, he shall furnish a copy
- 29 of such list to any candidate or party county chairman.] The
- 30 judge of election shall make the duplicate list available for

- 1 <u>inspection on the day of the election or primary subject to</u>
- 2 reasonable safeguards, rules and regulations including requiring
- 3 any individual who asks to inspect a list to identify himself,
- 4 and present identification that includes a photograph and
- 5 signature, by signing his name and printing his name and address
- 6 on a form prepared by the county board. The judge of election
- 7 shall post in a conspicuous public place within the polling
- 8 place of his district a sign stating that the duplicate list is
- 9 open to public inspection upon completion of the form.
- 10 Section 2. This act shall take effect in 60 days.
