## AN ACT

Amending the act of July 19, 1979 (P.L.130, No.48), entitled "An act relating to health care; prescribing the powers and duties of the Department of Health; establishing and providing the powers and duties of the State Health Coordinating Council, health systems agencies and Health Care 6 Policy Board in the Department of Health, and State Health 7 Facility Hearing Board in the Department of Justice; providing for certification of need of health care providers and prescribing penalties, "further providing for home care 10 agency and home care registry regulations. 11 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 12 13 Section 1.
