AN ACT

Authorizing the Department of General Services, with the
approval of the Governor, to grant and convey, at a price to
be determined through a public solicitation for proposals,
certain lands, buildings and improvements situate in the City
and County of Philadelphia, known as the Philadelphia State
Office Building.

- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. City of Philadelphia, Philadelphia County.
- 10 (a) Authorization. -- The Department of General Services, with
- 11 the approval of the Governor, is hereby authorized on behalf of
- 12 the Commonwealth of Pennsylvania to grant and convey the
- 13 following tract of land together with any buildings, structures
- 14 or improvements thereon, situate in the City and County of
- 15 Philadelphia, Pennsylvania. The Department shall sell the
- 16 property using a public solicitation for proposals.
- 17 (b) Description. -- The property to be conveyed pursuant to
- 18 section 1 consists of approximately 1.89-acres and an office
- 19 building bounded and more particularly described as follows:

- 1 ALL THAT CERTAIN lot or piece of ground situate in the Eighth
- 2 Ward of the City of Philadelphia, more fully bounded and
- 3 described as follows, to wit:
- 4 BEGINNING at a point of intersection of the Southerly side of
- 5 Spring Garden Street (120 feet wide) and the Westerly side of
- 6 Broad Street (113 feet wide); thence extending Southwardly along
- 7 the Westerly side of Broad Street 207 feet 8 inches to the point
- 8 of intersection of the Northerly side of Buttonwood Street (40
- 9 feet wide); thence extending Westwardly along the Northerly side
- 10 of Buttonwood Street 395 feet 8 inches to the Easterly side of
- 11 Fifteenth Street (50 feet wide); thence extending Northwardly
- 12 along the Easterly side of Fifteenth Street 207 feet 8 inches to
- 13 the Southerly side of Spring Garden Street; thence extending
- 14 Eastwardly along the Southerly side of Spring Garden Street 395
- 15 feet 8 inches to the first mentioned point and place of
- 16 BEGINNING.
- 17 CONTAINING approximately 1.89-acres more or less.
- 18 Being the same parcel and tract of land conveyed to the
- 19 Commonwealth of Pennsylvania, Department of General Services, by
- 20 the General State Authority in its deed, dated July 11, 1997,
- 21 recorded in the Philadelphia Recorder of Deeds Office in Deed
- 22 Book 398, Page 560.
- 23 (c) Conditions.--The conveyance shall be made under and
- 24 subject to all lawful and enforceable easements, servitudes and
- 25 rights of others, including but not confined to streets,
- 26 roadways and rights of any telephone, telegraph, water,
- 27 electric, gas or pipeline companies, as well as under and
- 28 subject to any lawful and enforceable estates or tenancies
- 29 vested in third persons appearing of record, for any portion of
- 30 the land or improvements erected thereon.

- 1 (d) Land use restriction. -- Any conveyance authorized under
- 2 this act shall be made under and subject to the condition, which
- 3 shall be contained in the deed of conveyance, that no portion of
- 4 the property conveyed shall be used as a licensed facility, as
- 5 defined in 4 Pa.C.S. § 1103 (relating to definitions), or any
- 6 other similar type of facility authorized under State law. The
- 7 condition shall be a covenant running with the land and shall be
- 8 binding upon the grantee, its successors and assigns. Should the
- 9 grantee, its successors or assigns, permit any portion of the
- 10 property authorized to be conveyed in this act to be used in
- 11 violation of this subsection, the title shall immediately revert
- 12 to and revest in the grantor.
- 13 (e) Deed.--The deed of conveyance shall be by Special
- 14 Warranty Deed and shall be executed by the Secretary of General
- 15 Services in the name of the Commonwealth of Pennsylvania.
- 16 (f) Costs and fees.--All costs and fees incurred by the
- 17 department in selling the property shall be paid from the
- 18 purchase price and that amount shall be an executively
- 19 authorized augmentation to the appropriation from which the
- 20 costs and fees were paid by the department. An amount equal to
- 21 any outstanding Commonwealth general obligation debt for the
- 22 renovations to the Philadelphia State Office Building from 1989
- 23 to present shall be deducted from the proceeds of the sale of
- 24 the building and deposited in the Capital Facilities Fund. The
- 25 balance of the proceeds of the sale shall be deposited in the
- 26 General Fund.
- 27 Section 2. Effective date.
- This act shall take effect immediately.
