- 11 of legal notices, or in two newspapers of general circulation
- 12 published in the county in which the initial registered office

- 14 newspaper of general circulation published in a county,
- 15 advertisements in that newspaper shall be sufficient.
- 16 Advertisements may appear prior to or after the day the articles
- 17 of incorporation are filed with the department and] Official
