## AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying 3 and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and imposing duties upon the Department of Revenue, certain 7 employers, fiduciaries, individuals, persons, corporations 9 and other entities; prescribing crimes, offenses and penalties," further providing for exclusion from the sales 10 11 tax. 12 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 13 14 Section 1. Section 204 of the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, is amended by 16 adding a clause to read: 17 Section 204. Exclusions from Tax. -- The tax imposed by section 202 shall not be imposed upon any of the following: 18 19
- 20 <u>(67) The sale at retail of a clothes washer, dishwasher,</u>

- 1 refrigerator, room air conditioner and ceiling fan purchased
- 2 <u>during the exclusion period by an individual purchaser for</u>
- 3 <u>nonbusiness use; provided the property qualifies as an "Energy</u>
- 4 Star" product pursuant to the United States Environmental
- 5 Protection Agency Energy Star Program as evidenced by the
- 6 property bearing an "Energy Star" label. The exclusion does not
- 7 <u>include the leasing, rental, repair or servicing of this</u>
- 8 property. For purposes of this clause, the phrase "exclusion
- 9 period" means the first full calendar weekend of October 2007
- 10 and April 2008. For purposes of this clause, "purchaser" means
- 11 an individual who places an order and pays the purchase price by
- 12 <u>cash</u>, <u>credit or other negotiable instrument during the exclusion</u>
- 13 period even if delivery takes place after the exclusion period.
- 14 For the purposes of this clause, the term "calendar weekend"
- 15 means Saturday and Sunday.
- 16 Section 2. This act shall take effect immediately.
