AN ACT

- 1 Requiring that cigarettes sold in this Commonwealth comply with
- the New York Fire Safety Standards for Cigarettes.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Fire-Safe
- 7 Cigarettes Act.
- 8 Section 2. Definitions.
- 9 The definitions set forth in Article XII of the act of March
- 10 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971,
- 11 shall apply to this act.
- 12 Section 3. Fire safety standards.
- 13 (a) New York Fire Safety Standards. -- No cigarette may be
- 14 sold or offered for sale to a person in this Commonwealth unless
- 15 the cigarette complies with the New York Fire Safety Standards
- 16 for Cigarettes in effect on January 1, 2007.
- 17 (b) Revisions.--Each pack of cigarettes that complies with

- 1 this section shall be marked in accordance with the New York
- 2 Fire Safety Standards for Cigarettes in effect on January 1,
- 3 2007. If these standards for marking packs of cigarettes change,
- 4 the Secretary of Revenue shall determine whether packs must be
- 5 marked in accordance with the existing or new standards.
- 6 Section 4. Enforcement.
- 7 (a) Regulations. -- The Secretary of Revenue shall promulgate
- 8 any regulations that are necessary for carrying out the
- 9 provisions of this act.
- 10 (b) Penalties.--Civil penalties may be assessed against a
- 11 person who knowingly sells cigarettes in violation of this act.
- 12 The penalty may not exceed \$10,000 for each sale.
- 13 (c) Powers and duties of Attorney General. -- In addition to
- 14 any other remedy provided by law, the Attorney General may file
- 15 any of the following actions against a person who violates this
- 16 act:
- 17 (1) A petition for injunctive relief.
- 18 (2) An action to recover damages for expenses incurred
- 19 by the Commonwealth as a result of the violation, including,
- 20 but not limited to, enforcement costs and attorney fees.
- 21 (3) Any other action which the Attorney General believes
- to be in the interest of the Commonwealth.
- 23 (d) Seizure of contraband. -- A cigarette that has been
- 24 offered for sale, possessed for sale or sold in violation of
- 25 this act shall be deemed contraband and may be subject to
- 26 seizure by the Commonwealth. The Secretary of Revenue shall
- 27 oversee the destruction of all seized cigarettes.
- 28 Section 5. Effective date.
- 29 This act shall take effect in 60 days.
