## AN ACT

- 1 Requiring a circulating nurse in certain operating rooms.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Circulating
- 6 Nurse Act.
- 7 Section 2. Purpose.
- 8 The purpose of this legislation is to require a registered
- 9 nurse to be the circulating nurse in an operating room for the
- 10 safety of the patient.
- 11 Section 3. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Conscious sedation." A minimally depressed level of

- 1 consciousness which retains the patient's ability to
- 2 independently and continuously maintain an airway and respond
- 3 appropriately to physical stimulation or verbal command,
- 4 produced by a pharmacologic or nonpharmacologic method, or
- 5 combination thereof.
- 6 "General anesthesia." A controlled state of unconsciousness,
- 7 including deep sedation, accompanied by the partial or complete
- 8 loss of protective reflexes which includes the patient's
- 9 inability to independently maintain an airway and respond
- 10 purposefully to physical stimulation or verbal command, produced
- 11 by a pharmacologic or nonpharmacologic method, or combination
- 12 thereof.
- 13 "Health care facility." Any health care facility providing
- 14 clinically related health services, including, but not limited
- 15 to, a general or special hospital, including psychiatric
- 16 hospitals, rehabilitation hospitals, ambulatory surgical
- 17 facilities, long-term care nursing facilities, cancer treatment
- 18 centers using radiation therapy on an ambulatory basis and
- 19 inpatient drug and alcohol treatment facilities, both profit and
- 20 nonprofit, and including those operated by an agency or State or
- 21 local government. The term shall also include a hospice. The
- 22 term shall not include an office used primarily for the private
- 23 or group practice by health care practitioners where no
- 24 reviewable clinically related health service is offered, a
- 25 facility providing treatment solely on the basis of prayer or
- 26 spiritual means in accordance with the tenets of any church or
- 27 religious denomination or a facility conducted by a religious
- 28 organization for the purpose of providing health care services
- 29 exclusively to clergy or other persons in a religious profession
- 30 who are members of the religious denominations conducting the

- 2 "MODERATE SEDATION." A MINIMALLY DEPRESSED LEVEL OF
- 3 CONSCIOUSNESS WHICH RETAINS THE PATIENT'S ABILITY TO
- 4 INDEPENDENTLY AND CONTINUOUSLY MAINTAIN AN AIRWAY AND RESPOND

- 5 APPROPRIATELY TO PHYSICAL STIMULATION OR VERBAL COMMAND,
- 6 PRODUCED BY A PHARMACOLOGIC OR NONPHARMACOLOGIC METHOD, OR
- 7 COMBINATION THEREOF.
- 8 "Operating room of the facility." The phrase shall only
- 9 include the number of operating rooms contained in the
- 10 ambulatory surgical facilities license issued by the
- 11 Pennsylvania Department of Health.
- 12 "Registered nurse." An individual licensed under the laws of
- 13 this Commonwealth to practice professional nursing.
- 14 Section 4. Operating room staff.
- Only a registered nurse, licensed in this Commonwealth,
- 16 qualified by training and experience in operating room nursing
- 17 shall be present as a circulating nurse during all surgical
- 18 procedures performed by a physician in a health care facility
- 19 for the duration of the procedure with the exception of surgical
- 20 procedures that are not performed under general anesthesia or
- 21 conscious MODERATE sedation in an ambulatory surgical facility.
- 22 Section 5. Effective date.
- 23 This act shall take effect in 60 days.
