## AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 4 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 13 Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of 14 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards, 17 and commissions; and prescribing the manner in which the number and compensation of the deputies and all other 18 19 assistants and employes of certain departments, boards and 20 commissions shall be determined," further providing for fees 21 chargeable by Department of State; and providing for a 22 uniform form.

- 25 Section 1. Section 618-A(1) of the act of April 9, 1929
- 26 (P.L.177, No.175), known as The Administrative Code of 1929, is

- 13 Section 2. Within 30 days of the effective date of this
- 14 section, the department shall make available and publish in the
- 15 Pennsylvania Bulletin a uniform form to request for the
- 16 legalization of documents. The form shall include all of the
- 17 following:
- 18 (1) Name of requester.
- 19 (2) Organization.
- 20 (3) Address.
- 21 (4) Telephone number.
- 22 (5) Country for which documents are being prepared.
- 23 (6) Number of documents to be certified.
- 24 (7) Whether the request is for legalization of documents
- for an international adoption proceeding.
- 26 (8) Signature of requester.

- 28 Section 3. This act shall take effect immediately.
