AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 2 Statutes, providing for the offense of aggressive driving.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Title 75 of the Pennsylvania Consolidated
- 6 Statutes is amended by adding a section to read:
- 7 § 3737. Aggressive driving.
- 8 (a) Offense defined. -- A person commits the offense of
- 9 aggressive driving if the person operates a vehicle in a manner
- 10 which endangers or is likely to endanger the safety of another
- 11 person or property when the offense involves the commission of
- 12 two or more violations of the following sections in a single act
- 13 or series of acts in close proximity to another vehicle:
- 14 <u>Section 3112 (relating to traffic-control signals).</u>
- Section 3303 (relating to overtaking vehicle on the
- left).
- 17 Section 3304 (relating to overtaking vehicle on the

- 4 <u>Section 3306 (relating to limitations on driving on left</u>
- 5 <u>side of roadway</u>).
- 6 <u>Section 3307 (relating to no-passing zones).</u>
- 7 <u>Section 3308 (relating to one-way roadways and rotary</u>
- 8 traffic islands).
- 9 <u>Section 3309 (relating to driving on roadways laned for</u>
- 10 <u>traffic</u>).
- 11 <u>Section 3310 (relating to following too closely).</u>

- 13 <u>Section 3362 (relating to maximum speed limits).</u>
- 14 (b) Penalties. -- Any person violating subsection (a) commits
- 15 <u>a summary offense and shall, upon conviction, be sentenced to</u>
- 16 pay a fine of \$300.
- 17 Section 2. This act shall take effect in 60 days.
