## AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the 2 Pennsylvania Consolidated Statutes, further providing for the 3 number of judges in the courts of common pleas.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 911(a) of Title 42 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 911. Courts of common pleas.
- 9 (a) General rule. -- There shall be one court of common pleas
- 10 for each judicial district of this Commonwealth consisting of

- 3 initially filled by election at the 2009 municipal election.
- 4 (2) The new judgeship for the thirty-ninth judicial
- district of this Commonwealth added by the amendment of 42
- 6 Pa.C.S. § 911(a) shall be established on January 2, 2012, and
- 7 shall be initially filled by election at the 2011 municipal
- 8 election.
- 9 Section 3. This act shall take effect in 60 days.
