AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public
- 3 welfare laws of the Commonwealth, "providing for veterans.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. The act of June 13, 1967 (P.L.31, No.21), known
- 7 as the Public Welfare Code, is amended by adding a section to
- 8 read:
- 9 <u>Section 215. Veterans.--(a) The department shall make a</u>
- 10 good faith effort to determine whether an applicant for cash or
- 11 medical assistance is a veteran. While in the process of making
- 12 <u>its determination</u>, the department shall dispense benefits to the
- 13 applicant, if otherwise eligible.

- 1 (b) As a condition of eligibility to receive cash or medical
- 2 <u>assistance</u>, an applicant who is a veteran shall be required to
- 3 contact a veteran service officer accredited and recognized by
- 4 the United States Department of Veterans Affairs, the Department
- 5 of Military and Veterans Affairs or the county director of
- 6 veterans affairs in which the applicant resides in order to
- 7 <u>determine the applicant's eliqibility for veteran's benefits or</u>
- 8 to file a veteran claims packet. THE DEPARTMENT SHALL DEVELOP A
- 9 STANDARD FORM TO BE USED BY A VETERAN SERVICE OFFICER TO VERIFY
- 10 THE APPLICANT'S ELIGIBILITY FOR VETERAN BENEFITS.
- 11 (c) An applicant who is a veteran shall provide proof of
- 12 compliance with this section and the department shall, to the
- 13 greatest extent possible, require the applicant to provide
- 14 information on the final determination of eligibility for
- 15 <u>veteran benefits and the type of benefits the veteran is</u>
- 16 entitled to receive.
- 17 (d) As used in this section, the following words and phrases
- 18 shall have the following meanings:
- 19 "Assistance" means money, services and payment for medical
- 20 <u>coverage for needy persons who are residents of this</u>
- 21 Commonwealth, are in need of assistance and meet all conditions
- 22 of eligibility.
- 23 <u>"Veteran claims packet" means an application requesting a</u>
- 24 <u>determination or entitlement or evidencing a belief in</u>
- 25 entitlement to a benefit as provided for in 38 CFR (relating to
- 26 pensions, bonuses, and veterans' relief) or 51 Pa.C.S. (relating
- 27 to military affairs).
- 28 Section 2. This act shall take effect immediately.
