- 1 "ENERGY CONSERVATION MEASURE." A PROGRAM [OR], FACILITY
- 2 ALTERATION OR TECHNOLOGY UPGRADE DESIGNED TO REDUCE ENERGY,
- 3 WATER, WASTEWATER OR OTHER CONSUMPTION OR OPERATING COSTS. THE
- 4 TERM MAY INCLUDE, WITHOUT LIMITATION:
- 5 (1) INSULATION OF THE BUILDING STRUCTURE OR SYSTEMS
- 6 WITHIN THE BUILDING.
- 7 (2) STORM WINDOWS OR DOORS, CAULKING OR WEATHER

- 2 (D) SELECTION AND NOTICE. -- THE GOVERNMENTAL UNIT SHALL
- 3 SELECT THE QUALIFIED PROVIDER THAT BEST MEETS THE NEEDS OF THE
- 4 GOVERNMENTAL UNIT IN ACCORDANCE WITH CRITERIA ESTABLISHED BY THE
- 5 GOVERNMENTAL UNIT. FOR GOVERNMENTAL UNITS THAT ARE NOT REQUIRED
- 6 TO TAKE ACTIONS ON CONTRACTS AT PUBLIC MEETINGS, THE
- 7 GOVERNMENTAL UNIT SHALL PROVIDE PUBLIC NOTICE OF THE AWARD OF
- 8 THE GUARANTEED ENERGY SAVINGS CONTRACT WITHIN 30 DAYS IN THE
- 9 PENNSYLVANIA BULLETIN. THE NOTICE SHALL INCLUDE THE NAMES OF THE
- 10 PARTIES TO THE CONTRACT AND THE PURPOSE OF THE CONTRACT. FOR
- 11 GOVERNMENTAL UNITS THAT ARE REQUIRED TO TAKE ACTIONS ON
- 12 CONTRACTS AT PUBLIC MEETINGS, THE PUBLIC NOTICE SHALL BE MADE AT
- 13 LEAST TEN DAYS PRIOR TO THE MEETING. AFTER REVIEWING THE
- 14 PROPOSALS PURSUANT TO SUBSECTION (E), A GOVERNMENTAL UNIT MAY
- 15 ENTER INTO A GUARANTEED ENERGY SAVINGS CONTRACT WITH A QUALIFIED
- 16 PROVIDER IF IT FINDS THAT THE AMOUNT IT WOULD SPEND ON THE
- 17 ENERGY CONSERVATION MEASURES RECOMMENDED IN THE PROPOSAL WOULD
- 18 NOT EXCEED THE AMOUNT [TO BE SAVED IN BOTH ENERGY AND
- 19 OPERATIONAL COSTS] OF ENERGY, OPERATIONAL, WATER OR WASTEWATER
- 20 COST SAVINGS OR REVENUE INCREASES RESULTING FROM THE ENERGY

- 7 (A) GENERAL RULE. -- A GUARANTEED ENERGY SAVINGS CONTRACT MAY <---
- 8 PROVIDE THAT ALL PAYMENTS, EXCEPT OBLIGATIONS ON TERMINATION OF
- 9 THE CONTRACT BEFORE ITS SCHEDULED EXPIRATION, SHALL BE MADE OVER
- 10 A PERIOD OF TIME. [EVERY GUARANTEED ENERGY SAVINGS CONTRACT
- 11 SHALL PROVIDE THAT THE SAVINGS IN ANY YEAR ARE GUARANTEED TO THE
- 12 EXTENT NECESSARY TO MAKE PAYMENTS UNDER THE CONTRACT DURING THAT
- 13 YEAR.] ANNUAL REVENUES OR SAVINGS FROM THE GUARANTEED ENERGY
- 14 SAVINGS CONTRACT MAY BE LESS THAN ANNUAL PAYMENTS, IF DURING THE
