- 13 This chapter shall be known and may be cited as the Emergency
- 14 Medical Services System Act.
- 15 § 7202. Declaration of policy.
- The General Assembly finds and declares as follows:
- 17 (1) Emergency medical services is an essential public
- 18 service and frequently the health care safety net for many
- 19 Commonwealth residents.
- 20 (2) It is in the public interest to assure that there
- 21 <u>are high quality and coordinated emergency and urgent medical</u>
- 22 services readily available to the residents of this
- 23 Commonwealth to prevent premature death and reduce suffering
- 24 and disability which arise from severe illness and injury.
- 25 (3) The public interest under paragraph (2) is best
- 26 achieved through a regulated and coordinated emergency
- 27 medical services system.
- 28 (4) Transportation of both emergency and nonemergency
- 29 <u>patients is an integral part of the health care delivery</u>
- 30 system in this Commonwealth, and it is in the public interest

Т	that the emergency medical services system serve all persons
2	in this Commonwealth who:
3	(i) require medical care to address illness or
4	<u>injury;</u>
5	(ii) need transport to a hospital or other health
6	care facility to receive that care; and
7	(iii) require medical assessment, monitoring,
8	assistance, treatment or observation during any
9	<u>transport.</u>
LO	(5) It serves the public interest if the emergency
L1	medical services system is able to quickly adapt and evolve
L2	to meet the needs of the residents of this Commonwealth for
L3	emergency and urgent medical care and to reduce their illness
L4	and injury risks.
L5	(6) It serves the public interest if the emergency
L6	medical services system provides community-based health
L7	promotion services that are integrated with the overall
L8	health care system.
L9	(7) Emergency medical services should be acknowledged,
20	promoted and supported as an essential public service.
21	(8) This chapter shall be liberally construed to
22	establish and maintain an effective and efficient emergency
23	medical services system which is accessible on a uniform
24	basis to residents of this Commonwealth and to visitors to
25	this Commonwealth.
26	(9) Residents of this Commonwealth and visitors to this
27	Commonwealth should have prompt and unimpeded access to
28	urgent and emergency medical care throughout this
29	Commonwealth.
30	(10) The Department of Health should continually assess

18	The following words and phrases when used in this chapter
19	shall have the meanings given to them in this section unless the

21	"Advanced emergency medical services." Emergency medical
22	services exceeding the scope of practice of an emergency medical
23	technician.
24	"Advanced emergency medical technician." An individual who
25	is certified by the Department of Health as an advanced
26	emergency medical technician.
27	"Advanced life support squad vehicle." A vehicle which:
28	(1) is maintained or operated to transport emergency
29	medical service providers above the advanced emergency
3 0	medical technician level equipment and supplies to

- 3 and
- 4 (2) is not used in the transport of patients.
- 5 <u>"ALS." Advanced life support.</u>
- 6 <u>"Ambulance." A ground, water or air vehicle which is</u>
- 7 maintained or operated for the purpose of providing emergency
- 8 medical services to and transportation of patients.
- 9 <u>"Ambulance attendant." An individual who is 16 years of age</u>
- 10 or older and satisfies one of the following:
- 11 (1) Possesses a certificate evidencing successful
- 12 <u>completion of an advanced first aid course sponsored by the</u>
- 13 American Red Cross and a current certificate evidencing
- 14 <u>successful completion of a cardiopulmonary resuscitation</u>
- course acceptable to the Department of Health.
- 16 (2) Possesses a current certificate evidencing
- 17 successful completion of a course determined by the
- 18 Department of Health to be equivalent to the requirements in
- 19 paragraph (1).
- 20 <u>"Basic emergency medical services." Emergency medical</u>
- 21 services included within but not exceeding the scope of practice
- 22 of an emergency medical technician.
- 23 "Basic life support squad vehicle." A vehicle which:
- 24 (1) is maintained or operated to transport emergency
- 25 medical services providers, equipment and supplies to
- 26 rendezvous with the crew of an ambulance for the purpose of
- 27 providing emergency medical services at or below the advanced
- 28 <u>emergency medical technician level to patients; and</u>
- 29 (2) is not used in the transport of patients.
- 30 "BLS." Basic life support.

- 1 "Board." The State Advisory Board, which is the Board of
- 2 Directors of the Pennsylvania Emergency Health Services Council.
- 3 <u>"Commonwealth emergency medical services medical director."</u>
- 4 A physician who is approved and employed by the Department of
- 5 <u>Health to advise and formulate policy on matters pertaining to</u>
- 6 <u>emergency medical services</u>.
- 7 <u>"Department." The Department of Health of the Commonwealth.</u>
- 8 <u>"Emergency." A physiological or psychological illness or</u>
- 9 <u>injury of an individual such that a prudent layperson who</u>
- 10 possesses an average knowledge of health and medicine could
- 11 reasonably expect the absence of immediate emergency medical
- 12 services to result in:
- 13 (1) placing the health of the individual or, with
- 14 respect to a pregnant woman, the health of the woman or her
- 15 <u>unborn child, in serious jeopardy;</u>
- 16 (2) serious impairment of bodily functions; or
- 17 (3) serious dysfunction of a bodily organ or part.
- 18 "Emergency medical responder" or "EMR." An individual who is
- 19 certified by the Department of Health as an emergency medical
- 20 <u>responder</u>.
- 21 "Emergency medical services" or "EMS." Any of the following:
- 22 (1) The medical care, including medical assessment,
- 23 <u>monitoring</u>, treatment, transportation and observation, which
- 24 <u>may be provided to a person in responding to an actual or</u>
- 25 reported emergency to:
- 26 (i) prevent or protect against loss of life or a
- 27 deterioration in physiological or psychological
- 28 <u>condition; or</u>
- 29 <u>(ii) address pain or morbidity associated with the</u>
- 30 <u>person's condition.</u>

1	(2) The transport of an individual with medical
2	assessment, monitoring, treatment or observation of the
3	individual who, due to the individual's condition, requires
4	medical assessment, monitoring, treatment or observation
5	during the transport.
6	"Emergency medical services agency." An entity that engages
7	in the business or service of providing emergency medical
8	services to patients within this Commonwealth by operating any
9	of the following:
10	(1) An ambulance.
11	(2) An advanced life support squad vehicle.
12	(3) A basic life support squad vehicle.
13	(4) A quick response service.
14	(5) A special operations EMS service. This paragraph
15	includes, but is not limited to:
16	(i) a tactical EMS service;
17	(ii) a wilderness EMS service;
18	(iii) a mass-gathering EMS service; and
19	(iv) an urban search and rescue EMS service.
20	(6) A vehicle or service which provides emergency
21	medical services outside of a health care facility, as
22	prescribed by the Department of Health by regulation.
23	"Emergency medical services agency medical director." A
24	physician who is employed by, contracts with or volunteers with
25	an emergency medical services agency either directly or through
26	an intermediary to:
27	(1) evaluate the quality of patient care provided by the
28	emergency medical services providers utilized by the
29	emergency medical services agency; and
30	(2) provide medical guidance and advice to the emergency

- 1 medical services agency.
- 2 <u>"Emergency medical services provider."</u> Any of the following:
- 3 <u>(1) An emergency medical responder.</u>
- 4 (2) An emergency medical technician.
- 5 (3) An advanced emergency medical technician.
- 6 (4) A paramedic.
- 7 <u>(5) A prehospital registered nurse.</u>
- 8 (6) A prehospital physician extender.
- 9 <u>(7) A prehospital emergency medical services physician.</u>
- 10 (8) An individual prescribed by regulation of the
- 11 <u>Department of Health to provide specialized emergency medical</u>
- 12 services.
- "Emergency medical services system." The arrangement of
- 14 personnel, facilities and equipment to prevent and manage
- 15 <u>emergencies in a geographic area.</u>
- 16 "Emergency medical services vehicle operator." An individual
- 17 certified by the Department of Health to operate a ground
- 18 emergency medical services vehicle.
- 19 <u>"Emergency medical technician" or "EMT." An individual who</u>
- 20 is certified by the Department of Health as an emergency medical
- 21 <u>technician.</u>
- 22 "Facility." A physical location at which an entity operates
- 23 a health care facility licensed under Federal or State law.
- 24 "Foundation." The Pennsylvania Trauma Systems Foundation, a
- 25 nonprofit Pennsylvania corporation whose function is to accredit
- 26 trauma centers in this Commonwealth.
- 27 "Hospital." An institution having an organized medical staff
- 28 that is primarily engaged in providing to inpatients, by or
- 29 under the supervision of physicians, diagnostic and therapeutic
- 30 services or rehabilitation services for the care or

- 1 rehabilitation of injured, disabled, pregnant, diseased, sick or
- 2 mentally ill persons. The term includes a facility for the
- 3 diagnosis and treatment of disorders within the scope of
- 4 specific medical specialties. The term does not include a
- 5 <u>facility caring exclusively for the mentally ill.</u>
- 6 <u>"Medical command facility." A distinct unit which contains</u>
- 7 the necessary equipment and personnel for providing medical
- 8 command to and control over emergency medical services
- 9 providers.
- 10 <u>"Medical command order."</u> An order issued by a medical
- 11 command physician to an emergency medical services provider who
- 12 <u>is functioning on behalf of an emergency medical services</u>
- 13 agency.
- 14 "Medical command physician." A physician certified by the
- 15 Department of Health to give medical command orders to emergency
- 16 medical services providers.
- 17 "Medical monitoring." Performing continuous or periodic
- 18 observations of an individual's condition or continuation of an
- 19 ordered treatment plan for an individual to prevent pain,
- 20 <u>suffering or the exacerbation of a preexisting condition.</u>
- 21 "Medical observation." Performing continuous or periodic
- 22 observations of an individual's stable condition to determine
- 23 whether there is a change in that condition.
- 24 "Paramedic." An individual who is certified by the
- 25 <u>Department of Health as a paramedic.</u>
- 26 "Patient." An individual for whom an emergency medical
- 27 <u>services provider is:</u>
- 28 (1) providing emergency medical services on behalf of an
- 29 <u>EMS agency; or</u>
- 30 (2) required to provide emergency medical services on

- 1 behalf of an EMS agency because the individual's condition
- 2 requires or may require medical observation, monitoring,
- 3 <u>assessment or treatment for an illness, disease, injury or</u>
- 4 other disability.
- 5 <u>"Peer review." The evaluation by health care providers of</u>
- 6 the quality and efficiency of services ordered or performed by
- 7 <u>emergency medical services providers and physicians who direct</u>
- 8 <u>or supervise EMS providers under this chapter and the</u>
- 9 <u>regulations of the Department of Health.</u>
- 10 <u>"Physician." A person who has a currently registered license</u>
- 11 to practice medicine or osteopathic medicine in this
- 12 <u>Commonwealth</u>.
- 13 <u>"Prehospital emergency medical services physician." A</u>
- 14 physician who is certified by the Department of Health as a
- 15 <u>prehospital emergency medical services physician.</u>
- 16 <u>"Prehospital physician extender" or "PHPE." A physician</u>
- 17 <u>assistant who is certified by the Department of Health as a</u>
- 18 prehospital physician extender.
- 19 <u>"Prehospital registered nurse" or "PHRN." A registered nurse</u>
- 20 who is certified by the Department of Health as a prehospital
- 21 <u>registered nurse.</u>
- 22 "Ouick response service" or "ORS." An operation in which
- 23 emergency medical services providers of an EMS agency:
- 24 (1) respond to an actual, reported or perceived
- 25 <u>emergency; and</u>
- 26 (2) provide emergency medical services to patients
- pending the arrival of an ambulance.
- 28 <u>"Regional emergency medical services council." A nonprofit</u>
- 29 <u>incorporated entity or appropriate equivalent that is assigned</u>
- 30 by the Department of Health to:

- 1 (1) plan, develop, maintain, expand and improve
- 2 <u>emergency medical services systems within a specific</u>
- 3 <u>geographic area of this Commonwealth; and</u>
- 4 (2) coordinate those systems into a regional emergency
- 5 medical services system.
- 6 "Regional emergency medical services medical director." The
- 7 <u>medical director of a regional emergency medical services</u>
- 8 council.
- 9 <u>"Review organization." A committee which engages in peer</u>
- 10 review as authorized by the regulations of the Department of
- 11 <u>Health</u>.
- 12 "Rural area." An area outside urbanized areas as defined by
- 13 the United States Bureau of the Census.
- 14 "Special care unit." An appropriately equipped area of a
- 15 <u>hospital where provision has been made for a concentration of</u>
- 16 physicians, nurses and others who have special skills and
- 17 <u>experiences to provide medical care for critically ill patients.</u>
- 18 "Trauma center." A facility accredited as a trauma center by
- 19 the Pennsylvania Trauma Systems Foundation.
- 20 § 7204. Emergency medical services system programs.
- 21 (a) Planning and coordination. -- The department shall plan,
- 22 quide and coordinate programs on the following matters to
- 23 promote effective and efficient operation of Statewide and
- 24 <u>regional EMS systems:</u>
- 25 (1) The number and distribution of EMS providers and
- other persons integral to an EMS system, such as medical
- 27 command physicians and EMS agency medical directors, with
- 28 <u>appropriate training and experience.</u>
- 29 (2) Reasonably accessible training for EMS providers and
- 30 other persons integral to an EMS system, including clinical

Τ.	training and continuing education programs coordinated with
2	other programs providing similar, complementary and
3	supplemental training and education.
4	(3) The joining of personnel, facilities and equipment
5	coordinated through a communication system to ensure that EMS
6	requests will be handled by communications facilities that:
7	(i) utilize emergency medical telecommunications
8	screening to determine the appropriate emergency agency
9	<u>response;</u>
10	(ii) are accessible to the general public through a
11	common telephone number and, where feasible, through the
12	universal emergency telephone number 911; and
13	(iii) will have direct communications with
14	appropriate personnel facilities and equipment resources.
15	(4) The number and distribution of ambulances and other
16	EMS vehicles in which:
17	(i) ambulances and other vehicles meet appropriate
18	criteria relating to location, design, performance and
19	equipment; and
20	(ii) operators and other personnel staffing vehicles
21	meet appropriate training and experience requirements.
22	(5) The number and accessibility of facilities that:
23	(i) are collectively capable of providing EMS on a
24	continuous basis;
25	(ii) have appropriate specialty capabilities;
26	(iii) meet appropriate standards relating to
27	capacity, location, personnel and equipment; and
28	(iv) are coordinated with other health care
29	facilities and resource centers.
30	(6) Access and transportation to trauma centers and

- 1 specialty care receiving facilities.
- 2 (7) Transfer of patients between facilities or to
- 3 <u>programs offering necessary follow-up care and</u>
- 4 rehabilitation.
- 5 (8) Utilization of appropriate personnel, facilities and
- 6 <u>equipment of each entity providing EMS.</u>
- 7 (9) Regional EMS councils that provide persons residing
- 8 <u>in an EMS region, and who have no professional or financial</u>
- 9 <u>interest in the provision of health care, with an adequate</u>
- 10 opportunity to participate in the making of policy for the
- 11 <u>regional EMS system.</u>
- 12 (10) The provision of EMS to all persons requiring those
- 13 <u>services.</u>
- 14 (11) A standardized data collection system that covers
- all phases of the EMS incident, including, but not limited
- 16 <u>to, the dispatch report and contact, treatment and transport</u>
- of a patient in the EMS system.
- 18 (12) Programs of public education, information and
- 19 prevention, integrated with public health education and
- 20 <u>taking into account needs of visitors and residents,</u>
- 21 <u>concerning methods for accessing EMS and stressing</u>
- 22 dissemination of information as to first aid and
- 23 cardiopulmonary resuscitation.
- 24 (13) The provision of periodic comprehensive review and
- 25 <u>evaluation of the extent and quality of the EMS provided in</u>
- 26 each regional EMS system and reports to the department of
- 27 <u>each review or evaluation.</u>
- 28 (14) Plans to assure that each regional EMS system will
- 29 <u>be able to provide or secure EMS during mass casualty</u>
- 30 situations, natural disasters and declared states of

- 1 emergency in accordance with Chapter 71 (relating to general
- 2 provisions) and the instructions of the Pennsylvania
- 3 <u>Emergency Management Agency.</u>
- 4 (15) Appropriate intrastate and interstate arrangements
- 5 <u>for the provision of EMS as needed.</u>
- 6 (b) Limitations.--This section is intended to identify EMS
- 7 <u>objectives to be pursued and achieved by the department in its</u>
- 8 role as lead agency for EMS. Nothing herein shall be construed
- 9 to confer regulatory powers upon the department beyond those
- 10 conferred elsewhere in this chapter.
- 11 § 7205. Duties of department.
- 12 (a) Duty.--It shall be the duty of the department to assist
- in the development of local EMS systems; plan, guide and
- 14 coordinate development of regional EMS systems into a unified
- 15 Statewide system; and coordinate systems in this Commonwealth
- 16 with similar systems in neighboring states.
- 17 (b) Authority.--The department shall be the lead agency for
- 18 EMS in this Commonwealth. The department is authorized to:
- 19 (1) Coordinate a program for planning, developing,
- 20 <u>maintaining</u>, <u>expanding</u>, <u>improving</u> <u>and upgrading EMS systems</u>
- in this Commonwealth.
- 22 (2) Establish, by regulation, standards and criteria
- 23 governing the awarding and administration of contracts and
- 24 grants under this chapter for initiation, maintenance and
- improvement of regional EMS systems.
- 26 (3) Require collection and maintenance of patient data
- and information in EMS patient care reports by EMS agencies.
- 28 (4) Collect, as deemed necessary and appropriate, data
- 29 <u>and information regarding patients who utilize emergency</u>
- 30 <u>departments without being admitted to the facility and</u>

1	patients admitted through emergency departments, trauma
2	centers or directly to special care units, in a manner that
3	protects and maintains the confidential nature of patient
4	records. The data and information shall be reasonable in
5	detail and shall be collected pursuant to regulations issued
6	by the department. Data and information shall be limited to
7	that which may be used for specific planning, research and
8	quality improvement purposes and shall not be duplicative of
9	data and information already available to the department.
10	(5) Prepare and revise a Statewide EMS system plan under
11	section 7211 (relating to comprehensive plan).
12	(6) Define and approve training programs and accredit
13	educational institutions for EMS training of EMS providers.
14	(7) Provide technical assistance to local governments,
15	EMS agencies and other entities for the purpose of assuring
16	effective planning and execution of EMS.
17	(8) Administer contracts and grants authorized under
18	this chapter and other grants pertaining to EMS.
19	(9) Establish standards for the licensing, registration
20	and operation of EMS agencies, and inspect EMS agencies for
21	compliance with this chapter and regulations adopted under
22	this chapter.
23	(10) Maintain a quality improvement program for the
24	purpose of monitoring and improving the delivery of EMS.
25	(11) Promulgate regulations to establish standards and
26	criteria for EMS systems.
27	(12) Integrate all trauma centers accredited pursuant to
28	section 7207 (relating to Pennsylvania Trauma Systems
29	Foundation) into the Statewide EMS system.
30	(13) Recommend to 911 and other EMS agency dispatchers

- 3 (14) Investigate, based upon complaints and information
- 4 received, possible violations of this chapter and regulations
- 5 under this chapter and take disciplinary actions, seek
- 6 <u>injunctions and refer matters for criminal prosecution.</u>
- 7 (15) Investigate complaints concerning delivery of
- 8 <u>services by trauma centers and forward investigation results</u>
- 9 <u>to the appropriate accrediting entity with a recommendation</u>
- 10 <u>for action</u>.
- 11 (16) Enter into agreements with other states which may
- include, as appropriate to effectuate the purposes of this
- chapter, the acceptance of EMS resources of other states that
- do not fully satisfy the requirements of this chapter or
- regulations adopted under this chapter.
- 16 (c) EMS protocols. -- The department shall establish criteria
- 17 and protocols, including bypass protocols, for evaluation,
- 18 triage, treatment, transport, transfer and referral of patients
- 19 to ensure that they receive appropriate EMS and are transported
- 20 to the most appropriate facility. Regional EMS councils shall
- 21 not be eligible for contracts or grant funds or State EMS
- 22 Operating Fund disbursements unless they assist in ensuring
- 23 regional implementation of the criteria and protocols. Protocols
- 24 under this subsection are not subject to the rulemaking process.
- 25 § 7206. Emergency medical services patient care reports.
- 26 (a) Preparation. -- An EMS agency shall ensure that its
- 27 responding EMS providers complete an EMS patient care report for
- 28 <u>each response made in which it encounters a patient or a person</u>
- 29 who has been identified as a patient to the EMS agency, unless
- 30 the department by regulation exempts certain types of patient

- 1 contact from the reporting requirement. The department shall
- 2 <u>employ an electronic EMS patient care reporting process that</u>
- 3 <u>shall solicit standardized data and patient information. The</u>
- 4 <u>department may require an EMS agency to complete a different</u>
- 5 <u>standardized report or different fields in a standardized report</u>
- 6 based upon the type of resources the EMS agency uses in
- 7 responding. The department shall permit an EMS agency to file a
- 8 paper report for extraordinary reasons as determined by the
- 9 <u>department on a case-by-case basis.</u>
- 10 (b) Content.--The report shall contain information as
- 11 solicited on the form or other reporting process developed by
- 12 the department. The reporting process shall solicit essential
- 13 <u>information in reasonable detail. The department may also use</u>
- 14 the reporting process to collect data to enhance its ability to
- 15 carry out its responsibilities under sections 7204 (relating to
- 16 emergency medical services system programs) and 7205 (relating
- 17 to duties of department).
- 18 (c) Patient medical record. -- If a patient is transported to
- 19 a hospital or from a hospital to another health care facility,

28	(f) VendorsA vendor may not sell or otherwise provide or
29	offer reporting forms or software marketed as appropriate for

- its operations in this Commonwealth to the transportation,

- 1 <u>and provision of medical care incidental to transportation</u>,
- of patients and other persons requiring transport by EMS
- 3 <u>vehicles from locations outside this Commonwealth to</u>
- 4 <u>locations within this Commonwealth.</u>
- 5 (4) EMS vehicles owned and operated by an agency of the
- 6 Federal Government.
- 7 § 7230. Advanced life support ambulances.
- 8 (a) Purpose. -- An ALS ambulance crew provides medical
- 9 <u>assessment</u>, <u>triage</u>, <u>monitoring</u>, <u>treatment</u>, <u>transportation</u> and
- 10 observation of patients who require EMS above the skill level of
- 11 <u>an advanced EMT.</u>
- 12 (b) Staffing requirements.--
- (1) Except as otherwise provided in this section,
- 14 minimum staffing requirements for an ALS ambulance when
- responding to a call to provide EMS for a patient requiring
- 16 EMS above the skill level of an advanced EMT is one EMS
- 17 provider at or above the EMT level, one EMS provider above
- 18 the advanced EMT level and one EMS vehicle operator. Only the
- 19 two EMS providers need to respond if one of them is also the
- 20 EMS vehicle operator. When present, an EMS provider qualified
- 21 to provide the type and level of EMS required by the patient
- 22 must attend to the patient at the scene and during the
- 23 transport. If a member of the ambulance crew arrives at the
- 24 <u>scene before another crew member, that person shall begin</u>
- 25 providing EMS to the patient at that person's skill level.
- 26 (2) Minimum staffing requirements for an ALS ambulance
- is the same as for a BLS ambulance when the ALS ambulance
- 28 <u>responds to a call to provide EMS for a patient requiring EMS</u>
- 29 <u>at or below the skill level of an advanced EMT.</u>
- 30 § 7231. Air ambulances.

- 1 (a) Purpose. -- An air ambulance is a rotorcraft staffed by a
- 2 <u>crew that provides medical assessment, treatment, monitoring,</u>
- 3 observation and transportation of patients who require EMS where
- 4 time to administer definitive care is of the essence and
- 5 <u>transportation</u> by air ambulance to a facility able to provide
- 6 the care is faster than transportation by ground ambulance, or
- 7 require EMS provided by specialized equipment or providers not
- 8 available on a ground ambulance and the air ambulance can
- 9 provide this faster than the patient would receive such care at
- 10 <u>a receiving facility if transported by ground ambulance.</u>
- 11 (b) Staffing requirements.--Minimum staffing standards for
- 12 <u>an air ambulance when dispatched to provide or when providing</u>
- 13 medical assessment, treatment, monitoring, observation or
- 14 transportation of a patient is one pilot and two EMS providers
- 15 other than the pilot who are above the advanced EMT level, with
- 16 at least one of those two EMS providers specially trained in air
- 17 medical transport.
- 18 § 7232. Advanced life support squad vehicles.
- 19 (a) Purpose.--An ALS squad vehicle transports EMS providers
- 20 above the advanced EMT level, along with equipment and supplies,
- 21 to rendezvous with an ambulance crew, or to respond prior to
- 22 arrival of an ambulance, in order to provide medical assessment,
- 23 monitoring, treatment and observation of a patient who requires
- 24 EMS at or above the skill level of an advanced EMT. An ALS squad
- 25 vehicle does not transport patients.
- 26 (b) Staffing requirements.--Minimum staffing for an ALS
- 27 squad unit responding to a call to provide EMS for a patient who
- 28 requires EMS above the skill level of an advanced EMT shall be
- 29 one EMS provider above the advanced EMT level and one EMS
- 30 vehicle operator, except that the EMS provider may staff the

- 1 vehicle alone if the EMS provider is also an EMS vehicle
- 2 <u>operator</u>.
- 3 § 7233. Basic life support ambulances.
- 4 (a) Purpose. -- A BLS ambulance crew provides medical
- 5 assessment, triage, monitoring, treatment, transportation and
- 6 observation of patients who require EMS at or below the skill
- 7 <u>level of an advanced EMT and also transports patients who</u>
- 8 require EMS above the skill level of an advanced EMT when an EMS
- 9 provider above the level of an advanced EMT rendezvous with the
- 10 BLS ambulance before or during transport of the patient and
- 11 <u>accompanies the patient during the transport after arrival.</u>
- 12 (b) Staffing requirements.--
- (1) Except as provided in paragraph (2), minimum
- staffing for a BLS ambulance when responding to a call to
- 15 provide EMS is an ambulance attendant, EMR or EMT, a second
- 16 EMS provider at or above the EMT level, and an EMS vehicle
- 17 operator, except that only the two EMS providers need to
- 18 respond if one of them is also the EMS vehicle operator. When
- 19 present, an EMS provider above the EMR level must attend to
- 20 <u>the patient at the scene and during patient transport.</u>
- 21 (2) Two years after the effective date of this section.
- the minimum staffing for a BLS ambulance when responding to a
- 23 call to provide EMS is an EMS provider at or above the EMR
- level, an EMS provider at or above the EMT level, and an EMS
- 25 <u>vehicle operator, except that only two EMS providers need to</u>
- 26 respond if one of them is also the EMS vehicle operator. When
- 27 present, an EMS provider above the EMR level must attend to
- the patient at the scene and during patient transport.
- 29 (3) If dispatched to provide EMS for a patient who
- 30 requires EMS above the skill level of an advanced EMT, the

- 1 BLS ambulance shall respond as set forth in this subsection.
- 2 If the BLS ambulance crew members arrive at the scene before
- a higher-level EMS provider of an ALS ambulance or ALS squad
- 4 <u>vehicle</u>, the BLS crew members shall provide EMS to the
- 5 patient at their skill level, including transport of the
- 6 patient to a receiving facility if needed, until higher-level
- 7 EMS is afforded by the arrival of a higher-level EMS
- 8 provider, after which the BLS ambulance crew shall relinquish
- 9 <u>primary responsibility for the patient to the higher-level</u>
- 10 <u>EMS provider.</u>
- 11 (4) When transporting from a sending hospital a patient
- who requires EMS above the skill level of an advanced EMT, if
- 13 <u>a registered nurse, physician assistant or physician from the</u>
- sending or receiving hospital joins the ambulance crew,
- brings on board the ambulance all equipment and supplies to
- 16 provide the patient with reasonably anticipated EMS above the
- 17 skill level of an advanced EMT and attends to the patient
- during the patient transport, the minimum staffing
- 19 requirements for the BLS ambulance are as set forth in
- 20 paragraphs (1) and (2).
- 21 § 7234. Basic life support squad vehicles.
- 22 (a) Purpose. -- A BLS squad vehicle transports an EMS
- 23 provider, along with basic EMS equipment and supplies, to
- 24 respond prior to arrival of an ambulance in order to provide EMS
- 25 at or below the advanced EMT level of care. A BLS squad vehicle
- 26 is not utilized to transport patients.
- 27 (b) Staffing requirements.--Minimum staffing for a BLS squad
- 28 <u>vehicle when responding to a call to provide EMS for a patient</u>
- 29 <u>is one EMS provider at or above the EMT level and an EMS vehicle</u>
- 30 operator, except that an EMS provider who is also an EMS vehicle

- 1 operator may staff the vehicle alone.
- 2 § 7235. Quick response services.
- 3 (a) Purpose.--A QRS uses EMS providers to respond to calls
- 4 for EMS and provide EMS to patients before an ambulance arrives.
- 5 (b) Staffing requirements. -- The minimum staffing requirement
- 6 for a QRS is one EMS provider.
- 7 § 7236. Special operations emergency medical services.
- 8 (a) Purpose. -- A special operations EMS service provides EMS
- 9 <u>in situations or austere environments that require specialized</u>
- 10 knowledge, equipment or vehicles to access a patient or address
- 11 the patient's emergency medical needs. The department shall by
- 12 regulation provide for specific types of special operations EMS
- 13 <u>teams</u>.
- 14 (b) Personnel requirements.--By regulation, the department
- 15 <u>may establish additional training or expertise requirements for</u>
- 16 the EMS agency medical director and the EMS providers who staff
- 17 a special operations EMS service.
- 18 (c) Other requirements.--By regulation, the department may
- 19 establish staffing, equipment, supply and any other requirement
- 20 <u>for a special operations EMS service.</u>
- 21 (d) Extraordinary applications. -- An entity may propose to
- 22 provide a special operations EMS need that has not been
- 23 addressed by applying to the department for an EMS agency
- 24 license to carry out the special operations EMS or, if it is
- 25 <u>licensed as an EMS agency, the entity may apply to the</u>
- 26 department to be authorized to provide the special operations
- 27 EMS under its license. The department shall address each
- 28 application on an individual basis and may conditionally deny or
- 29 grant an application as appropriate to protect the public health
- 30 and safety. The grant of an application shall be subject to

- 1 compliance with any later-adopted regulations addressing the
- 2 type of special operations EMS being provided by the entity.
- 3 (e) Protocols.--The department may include in its Statewide
- 4 EMS protocols special operations EMS protocols.
- 5 § 7237. First aid and other safety services.
- 6 (a) Purpose. -- An EMS agency may provide EMS at industrial
- 7 sites, amusement parks or other locations in need of the
- 8 service. No ambulance or other EMS vehicle shall be required for
- 9 <u>this purpose</u>.
- 10 (b) Staffing. -- The minimum staffing requirement is one EMS
- 11 provider.
- 12 (c) Other requirements. -- As assigned by the EMS agency, the
- 13 EMS provider may provide EMS and other medical safety services
- 14 up to the level for which the EMS provider has the credentials
- 15 to provide EMS for the EMS agency.
- 16 (d) Protocols. -- An EMS provider shall follow protocols
- 17 approved by the department when providing EMS under this
- 18 section.
- 19 § 7238. Other vehicles and services.
- 20 The department may by regulation prescribe EMS vehicle and
- 21 <u>service standards for EMS vehicles and services not specified in</u>
- 22 this chapter. If the department establishes standards under this
- 23 section, an EMS agency license shall be required to operate the
- 24 EMS vehicle or provide the service, and an EMS agency may not
- 25 operate the vehicle or provide the service unless approved to do
- 26 so by the department.
- 27 § 7239. Stretcher and wheelchair vehicles.
- 28 <u>(a) Stretcher vehicle.--A stretcher vehicle is a ground</u>
- 29 <u>vehicle other than an ambulance that is utilized to transport by</u>
- 30 stretcher persons who do not receive and cannot reasonably be

- 1 anticipated to require medical assessment, monitoring, treatment
- 2 or observation during transport, but who, due to their physical
- 3 condition, require vehicle transport while on a stretcher or in
- 4 a wheelchair.
- 5 (b) Wheelchair vehicle. -- A wheelchair vehicle is a ground
- 6 vehicle other than an ambulance that is used to transport by
- 7 wheelchair persons who do not receive and cannot reasonably be
- 8 <u>anticipated to require medical assessment, monitoring, treatment</u>
- 9 or observation during transport, but who, due to their physical
- 10 condition, require vehicle transport while on a stretcher or in
- 11 <u>a wheelchair.</u>
- (c) Prohibition. -- Operation by an entity of a stretcher
- 13 <u>vehicle or wheelchair vehicle to transport a person who is known</u>
- 14 or reasonably should be known by the entity to require medical
- 15 <u>assessment</u>, <u>monitoring</u>, <u>treatment or observation during</u>
- 16 transport shall constitute unlawful operation of an ambulance
- 17 for purposes of section 7256(a) and (c) (relating to penalties),
- 18 and if used as an ambulance by an EMS agency shall constitute
- 19 misconduct in operating an EMS agency under section 7242(a)(7)
- 20 (relating to emergency medical services agency license
- 21 sanctions). For purposes of this section, unlawful operation
- 22 includes, but is not limited to, the transport of the person to
- 23 or from a facility, a physician's office or any other location
- 24 to receive or from which the person received health care
- 25 services.
- 26 § 7240. Conditional temporary licenses.
- 27 When an EMS agency or an applicant for a license to operate
- 28 as an EMS agency does not provide service 24 hours per day and
- 29 seven days per week or is unable to participate in a county-
- 30 level or broader-level emergency medical response plan approved

- 1 by the department, the department shall issue a conditional
- 2 temporary license for operation of the EMS agency when the
- 3 <u>department determines that it is in the public interest, subject</u>
- 4 to such terms as the department deems appropriate. A conditional
- 5 temporary license shall be valid for one year and may be renewed
- 6 as many times as the department determines that it is in the
- 7 public interest to do so.
- 8 § 7241. Plans of correction.
- 9 (a) Correction of violation. -- Upon determining that an EMS
- 10 agency has violated this chapter or regulations promulgated
- 11 under this chapter, the department may issue a written notice to
- 12 the EMS agency specifying the violation or violations that have
- 13 been found. The notice shall require the EMS agency to take
- 14 immediate action to discontinue the violation or submit a plan
- 15 of correction to the department, or both, to bring the EMS
- 16 agency into compliance with applicable requirements. If the
- 17 nature of the violation is such that the EMS agency cannot
- 18 remedy the problem immediately, and a plan of correction is
- 19 therefore required, the department may direct that the violation
- 20 <u>be remedied within a specified period of time. The EMS agency</u>
- 21 shall submit a plan of correction within 30 days of the
- 22 department's issuance of the written notice. If immediate
- 23 corrective action is required, the notice from the department
- 24 <u>shall request</u>, and the EMS agency shall provide, prompt
- 25 <u>confirmation that the corrective action has been taken.</u>
- 26 (b) Discretion.--The department shall not afford the EMS
- 27 agency an opportunity to correct a violation without facing
- 28 <u>disciplinary charges if the department determines that it is not</u>
- 29 <u>in the public interest to do so.</u>
- 30 § 7242. Emergency medical services agency license sanctions.

- 1 (a) Grounds for discipline. -- The department may discipline
- 2 <u>an EMS agency or, as applicable, refuse to issue an EMS agency</u>
- 3 <u>license for any of the following reasons:</u>
- 4 (1) Violating the requirements of this chapter or
- 5 <u>regulation adopted under this chapter.</u>
- 6 (2) Failing to submit a plan of correction acceptable to
- 7 <u>the department or correct a deficiency as required under</u>
- 8 <u>section 7241 (relating to plans of correction) or failing to</u>
- 9 <u>comply with the plan of correction.</u>
- 10 (3) Refusing to accept a conditional temporary license
- 11 properly sought by the department or to abide by its terms.
- 12 (4) Fraud or deceit in obtaining or attempting to obtain
- 13 <u>a license.</u>
- 14 (5) Lending its license or, except as permitted under
- section 7229(f) (relating to emergency medical services
- 16 agencies), enabling another person to manage or operate the
- 17 EMS agency or any service covered by the license.
- 18 (6) Using the license of another or in any way knowingly
- 19 aiding or abetting the improper granting of a license,
- 20 <u>certification</u>, <u>accreditation</u> or <u>other authorization issued</u>
- 21 <u>under this chapter.</u>
- 22 (7) Incompetence, negligence or misconduct in operating
- 23 the EMS agency or in providing EMS to patients.
- 24 (8) The licensee is not a responsible person or is not
- 25 <u>staffed by responsible persons and refuses to remove from its</u>
- 26 <u>staff the irresponsible person or persons when directed to do</u>
- 27 so by the department. For purposes of this paragraph, "staff"
- and "responsible person" shall have the meanings set forth in
- 29 <u>section 7229(c)(1).</u>
- 30 (9) Refusing to respond to an emergency and render EMS

- 1 because of a patient's race, sex, creed, national origin,
- 2 <u>sexual preference</u>, age, handicap, medical problem or
- 3 <u>financial inability to pay.</u>
- 4 (10) Conviction of a felony, or a crime involving moral
- 5 <u>turpitude or related to the practice of the EMS agency.</u>
- 6 (11) Making misrepresentations in seeking funds made
- 7 available through the department.
- 8 (12) Failing to continue to meet applicable licensure
- 9 <u>requirements.</u>
- 10 (13) Violating an order previously issued by the
- 11 <u>department in a disciplinary matter.</u>
- 12 (b) Disciplinary options. -- If the department is empowered to
- 13 impose discipline against an EMS agency under this section, the
- 14 <u>department may do one or more of the following:</u>
- 15 (1) Deny the application for a license.
- 16 (2) Administer a written reprimand with or without
- 17 probation.
- 18 (3) Revoke, suspend, limit or otherwise restrict the
- 19 license.
- 20 (4) Impose a civil penalty not exceeding \$5,000 for each
- 21 <u>incident in which the EMS agency engages in conduct that</u>
- 22 constitutes a basis for discipline.
- 23 (5) Stay enforcement of any suspension, revocation or
- other discipline and place the facility on probation with the
- 25 <u>right to vacate the probationary order for noncompliance.</u>

- 6 § 7251. Limitations on liability.
- 7 The following shall apply:
- 8 (1) No medical command physician, medical command
- 9 <u>facility medical director or medical command facility, which</u>
- in good faith provides a medical command to an EMS provider
- or student enrolled in an EMS course of instruction approved
- by the department, shall be liable for civil damages as a
- result of issuing the instruction, absent a showing of gross
- 14 <u>negligence or willful misconduct.</u>
- 15 (2) No EMS agency, EMS agency medical director or EMS
- 16 provider who in good faith attempts to render or facilitate
- 17 emergency medical care authorized by this chapter shall be
- 18 liable for civil damages as a result of an act or omission,
- 19 absent a showing of gross negligence or willful misconduct.
- 20 This paragraph shall also apply to students enrolled in
- 21 approved courses of instruction and supervised pursuant to
- 22 rules and regulations.
- 23 (3) No approved EMS training institute nor any entity
- 24 participating as part of any approved educational program
- 25 <u>offered by the institute as authorized by this chapter shall</u>
- 26 be liable for any civil damages as a result of primary and
- 27 <u>continuing educational practice by duly enrolled students</u>
- 28 <u>under proper supervision, absent a showing of gross</u>
- 29 <u>negligence or willful misconduct.</u>
- 30 (4) No EMS provider who in good faith attempts to render

- 1 <u>emergency care authorized by this chapter at an emergency</u>
- 2 <u>scene while en route to a place of employment shall receive</u>
- 3 any form of reprimand or penalty by an employer as a result
- 4 <u>of late arrival at the place of employment. An employer may</u>
- 5 <u>require written verification from the EMS provider, who shall</u>
- 6 <u>obtain the written verification from either the police</u>
- 7 <u>officer or other person who is in charge at the emergency</u>
- 8 scene.
- 9 <u>(5) No EMS agency medical director or regional medical</u>
- 10 <u>director who in good faith gives instructions to or provides</u>
- 11 <u>primary and continuing educational training to an EMS</u>
- 12 <u>provider shall be liable for civil damages for issuing the</u>
- instructions, education or training, absent a showing of
- 14 gross negligence or willful misconduct.
- 15 (6) Neither the department, the Commonwealth EMS Medical
- 16 <u>Director, a regional EMS council medical director nor any</u>
- other official or employee of the department or a regional
- 18 EMS council shall be liable for civil damages arising out of
- 19 an EMS provider or a student enrolled in an EMS course of
- 20 <u>instruction approved by the department following protocols</u>
- approved under this chapter.
- 22 (7) No EMS provider or EMS agency may be subject to
- 23 <u>civil liability based solely on failure to obtain consent in</u>
- 24 rendering EMS to any person, regardless of age, where the
- 25 person is unable to give consent for any reason, including
- 26 minority, and where there is no other person reasonably
- 27 available who is legally authorized to give or refuse to give
- 28 consent, if the EMS provider has acted in good faith and
- 29 <u>without knowledge of facts negating consent.</u>
- 30 (8) No EMS provider or EMS agency may be subject to

- 1 <u>civil liability based solely on refusal to provide treatment</u>
- or services requested by the patient or the person
- 3 <u>responsible for making medical care decisions for the patient</u>
- 4 <u>if the treatment or services requested are not prescribed or</u>
- 5 <u>authorized by Statewide or regional protocols established</u>
- 6 under this chapter and the EMS provider has:
- 7 <u>(i) contacted a medical command physician who</u>
- 8 <u>refused to authorize the requested treatment or service;</u>
- 9 <u>or</u>
- 10 <u>(ii) made a good faith effort to contact a medical</u>
- 11 <u>command physician and was unable to do so.</u>
- 12 (9) No dispatcher of EMS who in good faith collects
- information about a patient from a caller or makes dispatch
- 14 assignments based upon the information collected may be
- subject to civil liability based upon the information
- 16 <u>collected or a dispatch assignment, absent a showing of gross</u>
- 17 negligence or willful misconduct.
- 18 § 7252. Peer review.
- 19 (a) Immunity from liability.--
- 20 (1) A person who provides information to a review
- 21 organization shall have the same protections from civil and
- 22 criminal liability as a person who provides information to a
- review organization under the act of July 20, 1974 (P.L.564,
- No.193), known as the Peer Review Protection Act.
- 25 (2) An individual who is a member or employee of a
- 26 review organization, or who furnishes professional counsel or
- 27 services to the organization, shall have the same protections
- 28 <u>from civil and criminal liability for the performance of any</u>
- 29 <u>duty, function or activity authorized or required of the</u>
- 30 review organization as a person who performs the duty.

- 1 function or activity under the Peer Review Protection Act.
- 2 (b) Confidentiality of review organization's records.--The
- 3 proceedings and records of a review organization shall be held
- 4 <u>in confidence and shall have the same protections from discovery</u>
- 5 and introduction into evidence in civil proceedings as they
- 6 would under the Peer Review Protection Act. A person who was in
- 7 attendance at a meeting of a review organization shall be
- 8 subject to the same testimony restrictions as a person who was
- 9 <u>in attendance at a meeting of a review organization under the</u>
- 10 Peer Review Protection Act.
- 11 § 7253. Support of emergency medical services.
- 12 (a) Emergency Medical Services Operating Fund. -- There is
- 13 <u>established a special fund to be known as the Emergency Medical</u>
- 14 Services Operating Fund, which shall be administered by the
- 15 <u>department</u>.
- 16 (b) Source. -- The following are the sources of the Emergency
- 17 Medical Services Operating Fund:
- 18 (1) Money collected under 75 Pa.C.S. §§ 3121 (relating
- 19 to EMS costs) and 3807(b)(1)(ix) (relating to Accelerated
- 20 <u>Rehabilitative Disposition</u>).
- 21 (2) All fees, fines and civil penalties collected by the
- department under this chapter.
- 23 (3) Appropriations.
- 24 <u>(4) Contributions.</u>
- 25 (c) Purpose of fund.--Except as provided under subsection
- 26 (d), 75% of the money from the Emergency Medical Services
- 27 Operating Fund shall be disbursed by the department for only the
- 28 <u>following uses:</u>
- 29 (1) To eligible EMS agencies for applicable purposes
- 30 stated under section 7212(c) (relating to contracts and

- 1 grants), with at least 10% of these funds to be allocated to
- 2 provide additional financial assistance for those EMS systems
- 3 <u>serving rural areas.</u>
- 4 (2) To the board for the performance of duties imposed
- 5 <u>upon it under this chapter.</u>
- 6 (3) To regional EMS councils for the development,
- 7 <u>maintenance and improvement of EMS systems, including</u>
- 8 ambulance and communications equipment and for training,
- 9 <u>education and EMS agency licensure purposes.</u>
- 10 (4) To other contractors and grantees as authorized
- 11 <u>under section 7212(j).</u>
- 12 (d) Allocation to Catastrophic Medical and Rehabilitation
- 13 Fund. -- Twenty-five percent of the money in the Emergency Medical
- 14 <u>Services Operating Fund shall be allocated to a Catastrophic</u>
- 15 Medical and Rehabilitation Fund for victims of trauma. After the
- 16 <u>exhaustion of all alternative financial resources</u>, other than
- 17 those excluded by the department from consideration, the
- 18 catastrophic fund shall be available for the purchase of
- 19 medical, rehabilitation and attendant care services for trauma
- 20 <u>victims and may be made available for the purchase of supportive</u>
