AN ACT

- 1 Banning the payment of bonuses to employees of the General 2 Assembly.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the General
- 7 Assembly Employee Bonus Ban Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Bonus." Monetary compensation given to an employee above
- 13 and beyond the employee's annual salary or other rate of pay.
- 14 The term does not include any of the following:
- 15 (1) Reimbursement or payment for expenses related to

- official business, including meals, housing, uniforms, car
- 2 allowance and other expenses.
- 3 (2) Severance payments pursuant to a personnel
- 4 compensation plan or contract, provided that the personnel
- 5 compensation plan or contract is in writing and open for
- 6 public inspection.
- 7 (3) Payments for unused vacation or sick leave.
- 8 (4) An annual cost-of-living adjustment equivalency
- 9 payment made to an individual, at the maximum of a salary
- 10 range, adopted pursuant to a personnel compensation plan,
- 11 provided that the personnel compensation plan is in writing
- 12 and open for public inspection.
- 13 (5) An arbitration award.
- 14 (6) Payments made pursuant to litigation.
- 15 (7) Overtime payments required for work performed in
- 16 excess of the maximum workweek.
- 17 (8) Annual performance-based incentive payments based on
- objective criteria made pursuant to a personnel compensation
- 19 plan included in an individual employment contract, provided
- 20 that the personnel compensation plan and contract are in
- 21 writing and open for public inspection.
- 22 "Employee." An employee of the General Assembly of the
- 23 Commonwealth.
- 24 Section 3. Bonus ban.
- No employee of the General Assembly may be paid a bonus.
- 26 Section 4. Penalties.
- 27 (a) Reimbursement.--An employee who is paid a bonus in
- 28 violation of the provisions of this act shall reimburse the
- 29 General Assembly the full amount of the bonus.
- 30 (b) Penalty.--An individual who intentionally approves or

- 1 authorizes a bonus in violation of this act commits a
- 2 misdemeanor of the third degree.
- 3 Section 5. Applicability.
- This act shall not abrogate any provision of an employment 4
- 5 contract which is in effect on the effective date of this
- 6 section.
- 7 Section 6. Effective date.
- This act shall take effect in 30 days. 8
