A RESOLUTION

1 Recognizing Mansfield University on the occasion of its 150th
2 anniversary.

3 WHEREAS, Mansfield Classical Seminary opened doors to its
4 first class in January 1857; and

5 WHEREAS, Mansfield Classical Seminary became Mansfield State
6 Normal School in 1862; and

7 WHEREAS, Mansfield State Normal School became Mansfield State
8 Teachers College in 1927; and

9 WHEREAS, Mansfield State Teachers College became Mansfield
10 State College in 1960; and

11 WHEREAS, Mansfield State College became Mansfield University
12 of Pennsylvania in 1983; and

1 WHEREAS, Character, culture, scholarship and service are the
2 foundation of all educational, social and athletic activities at
3 Mansfield University; and

4 WHEREAS, Mansfield University has served as the higher
5 education and cultural resource in the region; and

6 WHEREAS, Mansfield University has served as an educational
7 institution for seven generations of students who have become
8 leaders in their fields and have made significant contributions
9 to the world; therefore be it

10 RESOLVED, That the House of Representatives recognize
11 Mansfield University on the occasion of its 150th anniversary;
