2 Station Excellence Emmy and four category Emmys awarded by
3 the Mid-Atlantic Chapter of the National Academy of
4 Television Arts and Sciences on September 15, 2007.

5 WHEREAS, The House of Representatives is proud to recognize
6 the outstanding achievements of organizations that provide
7 integral services to the people of this Commonwealth; and

8 WHEREAS, WQED Multimedia, located in Pittsburgh,
9 Pennsylvania, was founded in 1954 as the first community-owned
10 television station in the United States and became a production
11 center of national programs for the Public Broadcasting Service;

13 WHEREAS, WQED Multimedia provides quality products and
14 services to engage, inform, educate and entertain the public
15 within its community and around the world; and

16 WHEREAS, More than one million households of viewers and

1 listeners rely on WQED each week, which is more than any other
2 Pittsburgh educational or cultural institution; and

3 WHEREAS, On September 15, 2007, WQED Multimedia was honored
4 with an unprecedented receipt of a second overall Station
5 Excellence Emmy and four category Emmys awarded by the Mid-
6 Atlantic Chapter of the National Academy of Television Arts and
7 Sciences; therefore be it

8 RESOLVED, That the House of Representatives honor WQED
9 Multimedia for their second overall Station Excellence Emmy,
10 along with Emmys awarded in the categories of Arts Program or
11 Special, Children/Youth/Teen Program or Special,
12 Historic/Cultural Program or Special and Community Service by
13 the Mid-Atlantic Chapter of the National Academy of Television
14 Arts and Sciences on September 15, 2007; and be it further
