1 2 3	Recognizing the week of November 19 through 25, 2007, as "Family Caregiver Week" in Pennsylvania and commending the service and dedication family caregivers provide to older adults.
4	WHEREAS, Most care provided to older adults at home is
5	delivered by family members, and according to Children of Aging
6	Parents, a Pennsylvania caregiver organization, an estimated
7	44.4 million Americans provide care for adult family members and
8	friends who, because of disabling illnesses or conditions, have
9	limited ability to carry out daily activities such as bathing,
10	managing medications or preparing meals; and
11	WHEREAS, Of all adults receiving long-term care at home, 78%
12	rely exclusively on family and friends to provide assistance;

WHEREAS, Of all people with Alzheimer's disease, 70% live at 2 3 home, where families provide at least 75% of their care; and 4 WHEREAS, Family involvement is critical to maintaining the independence of older adults who need assistance with activities 5 of daily living and avoiding premature institutionalization; and 6 7 WHEREAS, Older adults who live at home usually live longer 8 and spend more time with their families and communities, affording them a greater opportunity to continue to enrich this 9

10 Commonwealth by sharing their valuable wisdom, life experiences 11 and talents with other generations; and

12 WHEREAS, Primary caregivers who provide continuous care in 13 the home often gain a great deal of personal satisfaction, but 14 they can also experience physical, psychological and financial 15 stress; and

16 WHEREAS, Most Pennsylvania caregivers have provided care to 17 an impaired or disabled person or know someone who has; 18 therefore be it

19 RESOLVED, That the House of Representatives recognize the 20 week of November 19 through 25, 2007, as "Family Caregiver Week" 21 in Pennsylvania and commend the service and dedication of this 22 Commonwealth's family caregivers who improve the lives of many 23 older Pennsylvanians.
