A RESOLUTION

- 1 Designating May 10, 2008, as "Letter Carrier Food Drive Day" in
- 2 Pennsylvania; and commending the National Association of
- 3 Letter Carriers for its humanitarian efforts to eliminate
- 4 hunger.
- 5 WHEREAS, On Saturday, May 10, 2008, the National Association
- 6 of Letter Carriers will conduct its 16th annual NALC national
- 7 food drive to combat hunger; and
- 8 WHEREAS, This is the largest one-day food drive in the
- 9 nation, which is held in all 50 states and territories of the
- 10 United States; and
- 11 WHEREAS, On that day, letter carriers will collect
- 12 nonperishable donations as they deliver mail along their postal

- 1 routes; and
- WHEREAS, The food will be collected in over 10,000
- 3 communities by nearly 1,500 local branches of the postal union,
- 4 along with rural carriers and other volunteers; and
- 5 WHEREAS, Donations will be delivered to food banks, pantries
- 6 and shelters that serve the area where the donations are
- 7 collected; and
- 8 WHEREAS, The summer months are a particularly critical time
- 9 for millions of children whose school lunch programs are
- 10 suspended until fall and their families must find alternate
- 11 sources of nutrition; and
- 12 WHEREAS, Letter carriers see these families every day as they
- 13 deliver the mail and this food drive is one way to help
- 14 alleviate their plight; and
- 15 WHEREAS, Postal patrons are encouraged to participate by
- 16 leaving donations by their mailboxes on May 10; and
- 17 WHEREAS, Cosponsors of the drive are the United States Postal
- 18 Service, the Campbell Soup Company, Valpak/Cox Target Media,
- 19 Inc., local United Ways, the AFL-CIO and America's Second
- 20 Harvest food bank network; and
- 21 WHEREAS, Since its inception in 1993, the nationwide drive
- 22 has collected and delivered over three-quarters of a billion
- 23 pounds of food to help hungry families and last year carriers
- 24 collected 70.5 million pounds of food, which is the third
- 25 consecutive year the effort has exceeded 70 million pounds;
- 26 therefore be it
- 27 RESOLVED, That the House of Representatives declare May 10,
- 28 2008, as "Letter Carrier Food Drive Day" in Pennsylvania; and be
- 29 it further
- 30 RESOLVED, That the National Association of Letter Carriers

- and its cosponsors be commended for their humanitarian efforts
- 2 to stamp out hunger; and be it further
- RESOLVED, That the citizens of this Commonwealth be commended 3
- for their past participation in this food drive and encouraged 4
- to generously contribute to this year's effort to help feed the 5
- 6 hungry.
