## AN ACT

1 2 3 4 5 6 7 8 9 10 11 12	Amending the act of June 29, 1953 (P.L.304, No.66), entitled "An act providing for the administration of a statewide system of vital statistics; prescribing the functions of the State Department of Health, the State Advisory Health Board and local registrars; imposing duties upon coroners, prothonotaries, clerks of orphans' court, physicians, midwives and other persons; requiring reports and certificates for the registration of vital statistics; regulating the disposition of dead bodies; limiting the disclosure of records; prescribing the sufficiency of vital statistics records as evidence; prescribing fees and penalties; and revising and consolidating the laws relating thereto," providing for certificate of stillbirth.

- 9 <u>(6) THE STATEMENT: "THIS CERTIFICATE IS NOT PROOF OF LIVE</u> <—
- 10 BIRTH."
- 11 Such certificate shall not affect the registration, filing or
- 12 record requirements of this act, nor shall the issuance of such
- 13 <u>certificate impose upon a coroner or medical examiner any</u>
- 14 additional duties to conduct an investigation.
- 15 Section 2. This act shall take effect in 60 days.
