## AN ACT

1 2 3 4 5 6 7	Authorizing the Department of General Services, with the approval of the Governor, to grant and convey to Centre County, certain lands situate in Benner Township, Centre County; and authorizing the Department of General Services, with the approval of the Governor, to grant and convey, at a price determined through competitive bidding, certain lands situate in Benner Township, Centre County.
8	The General Assembly of the Commonwealth of Pennsylvania
9	hereby enacts as follows:
10	Section 1. Conveyance to Centre County in Benner Township,
11	Centre County, Pennsylvania.
12	(a) Authorization The Department of General Services, with
13	the approval of the Governor, is hereby authorized on behalf of

the Commonwealth of Pennsylvania to grant and convey to Centre

County certain land and improvements situate in Benner Township,

- 16 Centre County for \$1 and under terms and conditions to be
- 17 established in an Agreement of Sale with the Department of
- 18 General Services.

- 26 Section 3. Reservation and grant of easements.
- 27 To effectuate this act, the Department of General Services is
- 28 hereby authorized, on behalf of the Commonwealth of
- 29 Pennsylvania, to reserve or grant any such easements on the
- 30 property known as the State Correctional Institution at Rockview

- 1 as the Secretary of the Department of General Services shall
- 2 determine are appropriate or desirable, including, without
- 3 limitation, for access and utility service.
- 4 Section 4. Costs and fees.
- 5 All costs and fees incurred by the Department of General
- 6 Services in selling the property described in sections 1 and 2
- 7 shall be paid from the purchase price and that amount shall be
- 8 an executively authorized augmentation to the appropriation from
- 9 which the costs and fees were paid by the Department of General
- 10 Services. The balance of the proceeds of the sale shall be
- 11 deposited in the General Fund.

- 13 This act shall take effect immediately.
