## AN ACT

- 1 Authorizing and directing the Department of General Services,
- with the approval of the Governor and the Department of
- 3 Military and Veterans Affairs, to grant and convey certain
- lands situate in the City of Connellsville, a third class
- 5 city, Fayette County, to the City of Connellsville.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The Department of General Services, with the
- 9 approval of the Department of Military and Veterans Affairs and
- 10 the Governor, is hereby authorized and directed on behalf of the
- 11 Commonwealth of Pennsylvania to grant and convey, for \$50,000,
- 12 and under terms and conditions to be established in an agreement
- 13 of sale with the Department of General Services, the following
- 14 tract of land together with any buildings, structures or
- 15 improvements thereon, known as the National Guard Armory, 108
- 16 West Washington Avenue, Connellsville, Fayette County,
- 17 Pennsylvania, to the City of Connellsville, described in section
- 18 2.
- 19 Section 2. The property to be conveyed pursuant to section 1

- 1 consists of approximately 0.26-acres more or less known as 108
- 2 West Washington Avenue and more particularly bounded and
- 3 described as follows:
- 4 BEGINNING at the intersection of the northerly line of
- 5 Washington Avenue with the easterly line of Aetna Street; thence
- 6 south, eighty-nine (89) degrees fifty-five (55) minutes east,
- 7 ninety-four (94) feet along said northerly line to the westerly
- 8 line of an eighteen foot alley; thence at right angles along
- 9 said westerly line of said alley north, no (0) degrees five (5)
- 10 minutes east, one hundred twenty-one (121) feet to the southerly
- 11 line of another eighteen foot alley; thence at right angles
- 12 north, eighty-nine (89) degrees fifty-five (55) minutes west,
- 13 ninety-four (94) feet along said southerly line of said last
- 14 mentioned eighteen foot alley to said easterly line of Aetna
- 15 Street; thence at right angles south, no (0) degrees five (5)
- 16 minutes west, one hundred twenty-one (121) feet along said
- 17 easterly line of Aetna Street to the place of beginning.
- 18 Containing: 0.26-acres, more or less.
- 19 Section 3. The conveyance shall be made under and subject to
- 20 all lawful and enforceable easements, servitudes and rights of
- 21 others, including, but not confined to, streets, roadways and
- 22 rights of any telephone, telegraph, water, electric, gas or
- 23 pipeline companies, as well as under and subject to any lawful
- 24 and enforceable estates or tenancies vested in third persons
- 25 appearing of record, for any portion of the land or improvements
- 26 erected thereon.
- 27 Section 4. Any conveyance authorized under this act shall be
- 28 made under and subject to the condition, which shall be
- 29 contained in the deed of conveyance, that no portion of the
- 30 property conveyed shall be used as a licensed facility, as

- 1 defined in 4 Pa.C.S. § 1103 (relating to definitions), or any
- 2 other similar type facility authorized under State law. The
- 3 condition shall be a covenant running with the land and shall be
- 4 binding upon the Grantee, its successors and assigns. Should the
- 5 Grantee, its successors or assigns, permit any portion of the
- 6 property authorized to be conveyed in this act to be used in
- 7 violation of this subsection, the title shall immediately revert
- 8 to and revest in the Grantor.
- 9 Section 5. The deed of conveyance shall be by Special
- 10 Warranty Deed and shall be executed by the Secretary of General
- 11 Services in the name of the Commonwealth of Pennsylvania.
- 12 Section 6. Costs and fees incidental to this conveyance
- 13 shall be borne by the Grantee.
- 14 Section 7. The proceeds from the sale of the land and
- 15 building shall be deposited in the State Treasury Armory Fund.
- 16 Section 8. In the event the conveyance is not executed
- 17 within six months of the effective date of this act, the
- 18 Department of General Services may dispose of the property for
- 19 the Department of Military and Veterans Affairs in accordance
- 20 with section 2406-A of the act of April 9, 1929 (P.L.177,
- 21 No.175), known as The Administrative Code of 1929.
- 22 Section 9. This act shall take effect immediately.
