- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The sum of \$31,523,000, or as much thereof as may
- 10 be necessary, is hereby appropriated from the Professional
- 11 Licensure Augmentation Account within the General Fund to the
- 12 Department of State for the operation of the Bureau of
- 13 Professional and Occupational Affairs, including the State Board
- 14 of Auctioneer Examiners, for the fiscal year July 1, 2007, to
- 15 June 30, 2008.
- 16 Section 2. (a) The sum of \$8,165,000, or as much thereof as
- 17 may be necessary, is hereby appropriated from the restricted
- 18 receipts account of the State Board of Medicine for the
- 19 operation of the board for the fiscal year July 1, 2007, to June

- 1 30, 2008.
- 2 (b) The sum of \$1,223,000, or as much thereof as may be
- 3 necessary, is hereby appropriated from the restricted receipts
- 4 account of the State Board of Osteopathic Medicine for the
- 5 operation of the board for the fiscal year July 1, 2007, to June
- 6 30, 2008.
- 7 (c) The sum of \$252,000, or as much thereof as may be
- 8 necessary, is hereby appropriated from the restricted receipts
- 9 account of the State Board of Podiatry for the operation of said
- 10 board for the fiscal year July 1, 2007, to June 30, 2008.
- 11 (d) The sum of \$446,000, or as much thereof as may be
- 12 necessary, is hereby appropriated from the Athletic Commission
- 13 Augmentation Account for the State Athletic Commission, as
- 14 authorized by 5 Pa.C.S. § 1512 (relating to Athletic Commission
- 15 Augmentation Account), for the support and operation of the
- 16 commission for the fiscal year July 1, 2007, to June 30, 2008.
- (e) Each appropriation listed in subsections (a), (b), (c)
- 18 and (d) shall not be treated as an augmentation to the
- 19 Department of State, general government appropriation, or any
- 20 other appropriation, but shall be treated and accounted for as
- 21 separate appropriations respectively.
- 22 Section 3. This act shall take effect July 1, 2007, or
- 23 immediately, whichever is later.
