## AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An 2 act relating to tax reform and State taxation by codifying 3 and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, 5 collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and 7 imposing duties upon the Department of Revenue, certain 8 employers, fiduciaries, individuals, persons, corporations and other entities; prescribing crimes, offenses and 9 10 penalties," further providing for exclusion from the sales 11 tax.
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Section 204 of the act of March 4, 1971 (P.L.6,
- 15 No.2), known as the Tax Reform Code of 1971, is amended by
- 16 adding a clause to read:
- 17 Section 204. Exclusions from Tax. -- The tax imposed by
- 18 section 202 shall not be imposed upon any of the following:
- 19 \* \* \*

- 1 (67) The sale at retail of a clothes washer, dishwasher,
- 2 refrigerator, room air conditioner and ceiling fan purchased
- 3 during the exclusion period by an individual purchaser for
- 4 <u>nonbusiness use; provided the property qualifies as an "Energy</u>
- 5 <u>Star" product pursuant to the United States Environmental</u>
- 6 Protection Agency Energy Star Program as evidenced by the
- 7 property bearing an "Energy Star" label. The exclusion does not
- 8 <u>include the leasing, rental, repair or servicing of this</u>
- 9 property. For purposes of this clause, the phrase "exclusion
- 10 period" means the first full calendar weekend of October 2007
- 11 and April 2008. For purposes of this clause, "purchaser" means
- 12 <u>an individual who places an order and pays the purchase price by</u>
- 13 cash, credit or other negotiable instrument during the exclusion
- 14 period even if delivery takes place after the exclusion period.
- 15 For the purposes of this clause, the term "calendar weekend"
- 16 means Saturday and Sunday.
- 17 Section 2. This act shall take effect immediately.
