## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," providing for payment of fees associated with certification by the National Board for 6 Professional Teaching Standards. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 10 11 as the Public School Code of 1949, is amended by adding an 12 article to read: 13 ARTICLE XI-B 14 CERTIFICATION OF TEACHERS BY THE NATIONAL BOARD FOR 15 PROFESSIONAL TEACHING STANDARDS 16 Section 1101-B. - 2 "National Board for Professional Teaching Standards" or
- 3 "NBPTS." The independent, nonprofit organization established in
- 4 1987 to establish high standards for teachers' knowledge and
- 5 performance and for development and operation of a national
- 6 voluntary system to assess and certify teachers who meet those
- 7 standards.
- 8 "Public school." A school operated by a school district,
- 9 INTERMEDIATE UNIT, charter school, cyber charter school or an
- 10 area vocational-technical school.
- 11 Section 1102-B. Program.
- 12 (a) Establishment. -- A program to help defray the cost to
- 13 <u>teachers of becoming certified by the National Board for</u>
- 14 <u>Professional Teaching Standards is established.</u>
- 15 (b) Goal.--It is the goal of the Commonwealth to provide
- 16 opportunities and incentives for excellent teachers and to
- 17 retain them in the teaching profession. To attain this goal, the
- 18 Commonwealth shall support the efforts of teachers to achieve
- 19 <u>national certification by providing reimbursement for approved</u>
- 20 paid leave time for TO PUBLIC SCHOOLS FOR SUBSTITUTE FEES
- 21 ASSOCIATED WITH teachers participating in the certification
- 22 process and paying the assessment fee for teachers who seek to
- 23 attain national certification from the National Board for
- 24 Professional Teaching Standards.
- 25 <u>Section 1103-B. Payment of fees.</u>
- 26 Eligible teachers who participate in NBPTS certification
- 28 <u>extent funds are available, the Commonwealth shall do all of the</u>
- 29 following:
- 30 (1) Pay all or a portion of the cost of NBPTS assessment

- 1 <u>fees on behalf of an eliqible teacher to become NBPTS</u>
- 2 <u>certified or recertified.</u>
- 3 (2) Reimburse school districts for substitute fees for
- 4 <u>each day the eligible teacher participates in preparation for</u>
- 5 NBPTS certification, up to three days.
- 6 <u>Section 1104-B. Priority.</u>
- 7 (a) Schools in school improvement or corrective action.--
- 8 Eliqible teachers who teach in schools identified as in school
- 9 improvement or corrective action shall receive first priority
- 10 for payment of assessment fees under this article. The eliqible
- 11 <u>teachers' districts shall also receive first priority for</u>
- 12 substitute fees reimbursement.
- 13 (b) Other priority. -- Eligible teachers who teach early
- 14 childhood education, mathematics or science at the middle or
- 15 secondary level or who teach special education or foreign
- 16 languages shall receive second priority for payment of
- 17 assessment fees under this article. The eligible teachers'
- 18 districts shall also receive second priority for substitute fees
- 19 reimbursement.
- 20 Section 1105-B. Duties of eligible teachers.
- 21 (a) Completion of process. -- An eligible teacher on whose
- 22 behalf the assessment fee is paid shall agree to complete the
- 23 certification process or be subject to repayment as set forth in
- 24 section 1106-B(a).
- 25 (b) Three-year commitment. -- An eligible teacher on whose
- 26 behalf the assessment fee is paid and who receives NBPTS
- 27 certification shall, in addition to the requirement under
- 28 subsection (a), agree to serve as a teacher or administrator in
- 29 <u>a Pennsylvania public school for a period of at least three</u>
- 30 years or be subject to repayment as set forth in section 1106-

- 1 B(b). Eligible teachers who receive priority under section 1104-
- 2 <u>B and who receive NBPTS certification shall teach in that</u>
- 3 priority class for the three-year commitment period. If an
- 4 <u>eliqible teacher receives priority under section 1104-B(a) and</u>
- 5 the school is removed from improvement or corrective action
- 6 <u>during the three-year commitment period</u>, <u>service in the same</u>
- 7 school or in another school identified as in school improvement
- 8 or corrective action shall continue to fulfill the requirements
- 9 of this subsection.
- 10 Section 1106-B. Repayment.
- 11 (a) Failure to complete the certification process. -- When an
- 12 eligible teacher for whom the Commonwealth has paid the
- 13 assessment fee fails to complete the certification process, the
- 14 <u>teacher shall reimburse the Commonwealth for the amount of the</u>
- 15 <u>assessment fee. A candidate who completes the certification</u>
- 16 process but is denied NBPTS certification shall not be subject
- 17 to repayment pursuant to this subsection.
- 18 (b) Failure to continue teaching. -- When an eliqible teacher
- 19 for whom the Commonwealth has paid the assessment fee fails to
- 20 teach in a Pennsylvania public school for three consecutive
- 21 <u>years after completing the certification process</u>MEET THE
- 22 REQUIREMENTS OF SECTION 1105-B(B), the teacher shall reimburse
- 23 the Commonwealth for the amount of the assessment fee. The
- 24 teacher shall certify to the department each year that the
- 25 teacher is in compliance with section 1105-B(b).
- 26 (c) Waiver of repayment. -- Upon the application of the
- 27 eligible teacher, the department shall waive the repayment
- 28 requirement if the department finds that the teacher was unable
- 29 to complete the process or continue MEET THE REQUIREMENTS OF
- 30 <u>SECTION 1105-B(B)</u> FOR teaching in a priority class or school

- 1 <u>identified as in school improvement or corrective action due to</u>
- 2 <u>administrative action on the part of the school district or area</u>
- 3 vocational-technical school for other than causes enumerated in
- 4 <u>section 1122, or continue teaching due to illness of the</u>
- 5 teacher, the death or catastrophic illness of a member of the
- 6 <u>teacher's immediate family, or parental leave to care for a</u>
- 7 <u>newborn or newly adopted child and may waive the repayment</u>
- 8 requirement due to other extraordinary circumstances.
- 9 <u>Section 1107-B. Duties of department.</u>
- 10 (a) Guidelines. -- The department shall develop guidelines
- 11 necessary for the implementation of this article.
- 12 (b) Technical assistance. -- To the extent funds are
- 13 available, the department shall provide technical assistance to
- 14 NBPTS applicants. The department may contract with one or more
- 15 <u>institutions of higher education or intermediate units in order</u>
- 16 to provide technical assistance.
- 17 Section 2. This act shall take effect immediately.
