- The following words and phrases when used in this chapter
- 7 shall have the meanings given to them in this section unless the
- 8 context clearly indicates otherwise:
- 9 <u>"Crisis response services." Consultation, risk assessment,</u>
- 10 referral and onsite crisis intervention services provided by a
- 11 <u>critical incident stress management team to a law enforcement</u>
- 12 <u>officer who has employed the use of deadly force in the course</u>
- 13 and scope of the officer's employment.
- 14 <u>"Critical incident stress management team member." An</u>
- 15 <u>individual specially trained to provide crisis response services</u>
- 16 as a member of a police organization crisis response team that
- 17 holds membership in the Commonwealth's critical incident stress
- 18 management network.
- 19 "Debriefing session." A session during which crisis response
- 20 services are rendered by a critical incident stress management
- 21 team member during or after the use of deadly force by a law
- 22 enforcement officer.
- 23 "Law enforcement officer." Any of the following:
- 24 (1) A member of the Pennsylvania State Police.
- 25 (2) Any enforcement officer or investigator employed by
- the Pennsylvania Liquor Control Board.
- 27 (3) A parole agent, enforcement officer and investigator
- of the Pennsylvania Board of Probation and Parole.
- 29 (4) A Capitol Police officer.
- 30 (5) A Department of Conservation and Natural Resources

- 1 <u>ranger.</u>
- 2 (6) A drug enforcement agent of the Office of Attorney
- 3 General whose principal duty is the enforcement of the drug
- 4 <u>laws of this Commonwealth and a special agent of the Office</u>
- 5 of Attorney General whose principal duty is the enforcement
- of the criminal laws of this Commonwealth.
- 7 (7) Any member of a port authority or other authority
- 8 <u>police department.</u>
- 9 (8) Any police officer of a county, city, borough, town
- or township.
- 11 (9) Any sheriff or deputy sheriff.
- 12 § 4302. Confidential communications.
- 13 <u>(a) Disclosure.--Except as provided under subsection (b), a</u>
- 14 critical incident stress management team member who, while in
- 15 the course of his duties, has acquired information from any law
- 16 enforcement officer secretly and in confidence, may not be
- 17 compelled or allowed without the consent of the law enforcement
- 18 officer to disclose that information in a legal proceeding,
- 19 trial or investigation before any government unit.
- 20 (b) Exceptions. -- The testimonial privilege established under
- 21 subsection (a) shall not apply if any of the following apply:
- 22 (1) The communication or advice indicates clear and
- 23 present danger to the law enforcement officer who receives
- crisis response services or to other persons.
- 25 (2) The law enforcement officer who received crisis
- 26 response services gives express consent to the testimony.
- 27 (3) The law enforcement officer who received crisis
- 28 response services is deceased and the surviving spouse or the
- 29 executor or administrator of the estate of the deceased law
- 30 enforcement officer gives express consent.

1	(4) The law enforcement officer who received crisis
2	response services voluntarily testifies, in which case the
3	critical incident stress management team member may be
4	compelled to testify on the same subject.
5	(5) The court in camera determines that the information
6	communicated by the law enforcement officer who received
7	crisis response services is not germane to the relationship
8	between the law enforcement officer and the team member.
9	(6) The communication or advice pertains or is related
10	to any criminal act.
11	Section 2. This act shall take effect in 60 days.
