AN ACT

- 1 Requiring a circulating nurse in certain operating rooms.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Circulating
- 6 Nurse Act.
- 7 Section 2. Purpose.
- 8 The purpose of this legislation is to require a registered
- 9 nurse to be the circulating nurse in an operating room for the
- 10 safety of the patient.
- 11 Section 3. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:

- 1 "Anesthesia." Includes general anesthesia and spinal or-
- 2 major regional anesthesia. It does not include local anesthesia.
- 3 General anesthesia is a drug induced loss of consciousness-
- 4 during which patients are not arousable, even by painful
- 5 stimulation. The ability to independently maintain ventilatory
- 6 function is often impaired. Patients often require assistance in
- 7 maintaining a patent airway, and positive pressure ventilation
- 8 may be required because of depressed spontaneous ventilation or
- 9 drug-induced depression of neuromuscular function.
- 10 Cardiovascular function may be impaired.
- 11 "Deep sedation/analgesia." A drug-induced depression of
- 12 consciousness during which patients cannot be easily aroused but
- 13 respond purposefully following repeated or painful stimulation.
- 14 The ability to independently maintain ventilatory function may
- 15 be impaired. Patients may require assistance in maintaining a
- 16 patent airway, and spontaneous ventilation may be inadequate.
- 17 Cardiovascular function is usually maintained.
- 18 "Health care facility." Any hospital or class C ambulatory
- 19 surgical facility as defined by 28 Pa. Code Pt. IV (relating to
- 20 health facilities).
- 21 "Operating room of the facility." The phrase shall only
- 22 include the number of operating rooms covered by a health care
- 23 facility's license issued by the Department of Health.
- "Registered nurse." An individual licensed under the laws of
- 25 this Commonwealth to practice professional nursing.
- 26 Section 4. Operating room staff.
- Only a registered nurse, licensed in this Commonwealth,
- 28 qualified by training and experience in operating room nursing
- 29 shall function as a circulating nurse during all surgical
- 30 procedures performed in a health care facility under general

- 1 anesthesia or deep sedation in AN OPERATING ROOM OF a health
- 2 care facility's operating room FACILITY.
- 3 Section 5. Effective date.
- 4 This act shall take effect in 60 days.
