AN ACT

Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An 2 act relating to insurance; amending, revising, and consolidating the law providing for the incorporation of 3 insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds 5 associations, reciprocal and inter-insurance exchanges, and 6 7 fire insurance rating bureaus, and the regulation and supervision of insurance carried by such companies, 8 associations, and exchanges, including insurance carried by 9 the State Workmen's Insurance Fund; providing penalties; and repealing existing laws," providing for motor vehicle service 10 11 12 contracts. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. The act of May 17, 1921 (P.L.682, No.284), known 16 as The Insurance Company Law of 1921, is amended by adding a 17 section to read: Section 358. Motor Vehicle Service Contracts. -- (a) The 18 19 marketing, sale, offering for sale, issuance, making, proposing

to make and administration of a motor vehicle service contract

- 1 shall be construed as the business of insurance and shall be
- 2 <u>subject to regulation as insurance.</u>
- 3 (b) "Motor vehicle service contract" means a contract or an
- 4 agreement for a separately stated consideration for a specific
- 5 <u>duration to perform the service, repair, replacement or</u>
- 6 <u>maintenance of a motor vehicle or indemnification for service</u>,
- 7 repair, replacement or maintenance, for the operational or
- 8 structural failure due to a defect in materials, workmanship or
- 9 normal wear and tear with or without additional provisions for
- 10 incidental payment of indemnity under limited circumstances,
- 11 <u>including</u>, but not limited to, towing, rental and emergency road
- 12 service. The term "motor vehicle service contract" does not
- 13 include warranties issued by or from the original manufacturer
- 14 of a motor vehicle or a warranty, policy, rider or endorsement
- 15 issued by an insurer licensed or admitted to do business in this
- 16 Commonwealth.
- 17 Section 2. This act shall take effect in 60 days.
