A SUPPLEMENT

- To the act of July 7, 1972 (P.L.743, No.176), entitled "An act 1 providing for the establishment and operation of Lincoln 2 3 University as an instrumentality of the Commonwealth to serve as a State-related institution in the higher education system 4 of the Commonwealth; providing for change of name; providing 5 for the composition of the board of trustees; terms of 6 trustees, and the power and duties of such trustees; 7 providing for preference to Pennsylvania residents in 8 tuition; authorizing appropriations in amounts to be fixed 9 annually by the General Assembly; providing for the auditing 10 of accounts of expenditures from said appropriations; 11 providing for public support and capital improvements; 12 authorizing the issuance of bonds exempt from taxation within 13 the Commonwealth; requiring the President to make an annual 14 report of the operations of Lincoln University," making 15 16 Federal and State appropriations for carrying the same into effect; and providing for a basis for payments of the 17 appropriations, for a method of accounting for the funds 18 appropriated and for certain fiscal information disclosure. 19 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows: 22 The sum of \$13,623,000, or as much thereof Section 1. (a) 23 as may be necessary, is hereby appropriated from the General 24 Fund to the Trustees of Lincoln University, Chester County, for the fiscal year July 1, 2009, to June 30, 2010, for general 25 26 support.
 - (b) The sum of \$870,000, or as much thereof as may be

- 1 necessary, is hereby appropriated from Federal funds available
- 2 through the American Recovery and Reinvestment Act Fiscal
- 3 Stabilization Fund to the Trustees of Lincoln University,
- 4 Chester County, for the fiscal year July 1, 2009, to June 30,
- 5 2010, for general support.
- 6 Section 2. Payments to Lincoln University on account of the
- 7 appropriation in section 1 shall be made on the basis of costs
- 8 during the fiscal year.
- 9 Section 3. (a) Subject to the requirements of subsection
- 10 (c), payments to Lincoln University of the appropriation
- 11 provided in section 1 shall be made monthly during the fiscal
- 12 year.
- 13 (b) Such monthly payments shall be made in accordance with
- 14 the provisions of section 2 on the basis of estimated costs. The
- 15 estimate of costs shall be submitted by Lincoln University to
- 16 the Secretary of Education, the General Assembly and the State
- 17 Treasurer not later than 30 days prior to the date on which such
- 18 payment is to be made.
- 19 (c) No funds appropriated under this act shall be received
- 20 by Lincoln University unless the university agrees to enter into
- 21 articulation agreements with the community colleges and the
- 22 State System of Higher Education institutions pursuant to
- 23 Article XX-C of the act of March 10, 1949 (P.L.30, No.14), known
- 24 as the Public School Code of 1949, and agrees to participate in
- 25 a longitudinal data system operated by the Commonwealth
- 26 consistent with any applicable United States Department of
- 27 Education guidelines. Failure to implement agreements and
- 28 participate in the longitudinal data system for the 2010-2011
- 29 school year shall result in the university returning to the
- 30 Commonwealth payments received under this act.

- 1 Section 4. (a) Lincoln University shall apply the moneys
- 2 appropriated by this act only for such purposes as are permitted
- 3 in this act and shall at all times maintain proper records
- 4 showing the application of such moneys. Not later than 120 days
- 5 after the close of the fiscal year to which this act relates,
- 6 Lincoln University shall file, with the Secretary of Education,
- 7 the General Assembly and the Auditor General of the
- 8 Commonwealth, a statement setting forth the amounts and purposes
- 9 of all expenditures made from moneys appropriated by this act
- 10 and costs, as provided in section 2, used as a basis for receipt
- 11 of any appropriation during said fiscal year.
- 12 (b) Such statement of expenditures and costs shall be
- 13 reviewed by the Auditor General of the Commonwealth, and he
- 14 shall have the right, in respect to the moneys appropriated by
- 15 this act, to audit and disallow expenditures made for purposes
- 16 not permitted by this act and to cause such sums to be recovered
- 17 and paid by Lincoln University to the State Treasurer. In
- 18 respect to expenditures made by the university from moneys other
- 19 than those appropriated by this act, the Auditor General shall
- 20 have the right to review only, and he shall file annually with
- 21 the General Assembly such information concerning said
- 22 expenditures as the General Assembly or any of its committees
- 23 may require.
- 24 Section 5. Lincoln University shall provide full, complete
- 25 and accurate information as may be required by the Department of
- 26 Education or the chairman or the minority chairman of the
- 27 Appropriations Committee of the Senate or the chairman or the
- 28 minority chairman of the Appropriations Committee of the House
- 29 of Representatives.
- 30 Section 6. Lincoln University shall present and report its

- 1 financial statements required under the provisions of this act
- 2 in accordance with: the generally accepted accounting principles
- 3 as prescribed by the National Association of College and
- 4 University Business Officers, the American Institute of
- 5 Certified Public Accountants, or their successors, or by any
- 6 other recognized authoritative body; the "Commonwealth of
- 7 Pennsylvania Budget Instructions for the State System of Higher
- 8 Education, State-Related Universities and Non-State-Related
- 9 Colleges and Universities"; and the financial reporting policies
- 10 and standards promulgated by the Commonwealth of Pennsylvania
- 11 and by the Federal Government that apply to Lincoln University.
- 12 Section 7. Lincoln University shall make all articulation
- 13 agreements with other higher education institutions available on
- 14 the Internet.
- 15 Section 8. This act shall take effect July 1, 2009, or
- 16 immediately, whichever is later.
