- 7 subject to any lawful and enforceable estates or tenancies
- 8 vested in third persons appearing of record, for any portion of
- 9 the land or improvements erected thereon.
- 10 (d) Land use restriction. --
- 11 (1) The deed of conveyance shall contain the following
- restrictive covenant: "Under and subject to a condition that
- the land conveyed herein shall be used solely for
- 14 agricultural purposes in the furtherance of the Grantee's
- mission of education related to agricultural sciences. Should
- the Grantee attempt to convey the property, or utilize it for
- any other purpose, the property shall immediately revert to
- 18 the Grantor."
- 19 (2) The conveyance shall be made under and subject to a
- 20 restrictive covenant that the Grantee shall convey and record
- 21 a perpetual conservation easement to the Clearwater
- 22 Conservancy and the Department of Conservation and Natural
- 23 Resources as co-holders as that term is defined in the act of
- June 22, 2001 (P.L.390, No.29), known as the Conservation and
- 25 Preservation Easements Act, their successors and assigns,
- that the Grantee shall negotiate with the Clearwater
- 27 Conservancy and the Department of Conservation and Natural
- 28 Resources and the perpetual conservation easement shall be in
- 29 furtherance of the following conservation goals: to preserve
- 30 the property's unique natural resources, including the

- 1 biological resources, native species and their supporting
- 2 habitats which include native species that are uncommon in
- 3 this Commonwealth; and to preserve the integrity of Spring
- 4 Creek, currently designated as a high-quality cold water
- 5 fishery which requires the protection of the property's
- 6 groundwater recharge value and its springs, wetlands and
- 7 floodplains, consistent with and guided by the Master Site
- 8 Development Plan and Environmental Assessment, accepted by
- 9 the Department of Conservation and Natural Resources and
- 10 adopted by Benner Township. The covenant shall provide that
- in the event the perpetual conservation easement is not so
- 12 conveyed and recorded within two years of the effective date
- of the conveyance under subsection (a), then the property
- shall immediately revert to the Commonwealth of Pennsylvania.
- 15 (e) Gaming facility restriction. -- Any conveyance authorized
- 16 under this section shall be made under and subject to the
- 17 condition, which shall be contained in the deed of conveyance,
- 18 that no portion of the property conveyed shall be used as a
- 19 licensed facility, as defined in 4 Pa.C.S § 1103 (relating to
- 20 definitions), or any other similar type of facility authorized
- 21 under State law. The condition shall be a covenant running with
- 22 the land and shall be binding upon the Grantee, its successors
- 23 and assigns. Should the Grantee, its successors or assigns,
- 24 permit any portion of the property authorized to be conveyed in
- 25 this section to be used in violation of this subsection, the
- 26 title shall immediately revert to and revest in the Grantor.
- 27 (f) Execution. -- The deed of conveyance shall be by Special
- 28 Warranty Deed and shall be executed by the Secretary of General
- 29 Services in the name of the Commonwealth of Pennsylvania.
- 30 (q) Costs and fees.--Costs and fees incidental to this

- 1 conveyance shall be borne by the Grantee.
- 2 (h) Nonconveyance. -- In the event that this conveyance is not
- 3 executed within two years of the effective date of this section,
- 4 the authority contained in this section shall expire.

- 17 survey plan to be prepared by Sweetland Engineering &
- 18 Associates, Inc. under an agreement with the Department of
- 19 General Services.
- 20 Section 9. Costs, fees and deposit of proceeds.
- 21 The amount of all costs and fees incurred by the Department
- 22 of General Services in preparing the property contained in this
- 23 act for sale shall be deducted from proceeds of the sale and
- 24 transferred to the appropriation from which the costs and fees
- 25 were paid by the Department of General Services. The balance of
- 26 the proceeds of the sale shall be deposited in the General Fund.
- 27 Section 10. Effective date.
- This act shall take effect immediately.
