AN ACT

- 1 Designating the bridge in the Borough of Hatboro (now designated
- as Bridge Management I.D. No. 46/0263/0050/0057) over
- 3 Pennypack Creek as the PFC Joseph J. Lannon, Jr., USMC
- 4 Memorial Bridge.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. PFC Joseph J. Lannon, Jr., USMC Memorial Bridge.
- 8 (a) Declaration of policy. -- The General Assembly finds and
- 9 declares that PFC Joseph J. Lannon, Jr., USMC, made the ultimate
- 10 sacrifice for his country on October 1, 1968, while serving in
- 11 the United States Marine Corps, when he was killed in action in
- 12 Quang Nam, Vietnam.

- 1 (b) Designation. -- The bridge [over] (BRIDGE MANAGEMENT I.D.
- 2 NO. 46/263/0050/0057) SPANNING Pennypack Creek ON SOUTH YORK
- 3 ROAD (STATE ROUTE 263) in the Borough of Hatboro [shall be],
- 4 MONTGOMERY COUNTY, IS HEREBY designated as the PFC Joseph J.
- 5 Lannon, Jr., USMC Memorial Bridge.
- 6 (c) Signs. -- The Department of Transportation shall place and
- 7 maintain appropriate signs at both ends of the bridge designated
- 8 in subsection (b).
- 9 Section 2. Effective date.
- 10 This act shall take effect in 60 days.
