## AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania 2 Consolidated Statutes, in assault, further providing for the offense of aggravated assault. 3 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: 6 Section 1. Section 2702(a)(5) of Title 18 of the Pennsylvania Consolidated Statutes is amended to read: 8 SECTION 1. SECTION 2702(A)(5) AND (C)(2) AND (27) OF TITLE 18 OF THE PENNSYLVANIA CONSOLIDATED STATUTES ARE AMENDED TO 10 READ: § 2702. 11 Aggravated assault. 12 Offense defined. -- A person is guilty of aggravated 13 assault if he:

- 15 (5) attempts to cause or intentionally or knowingly

- 5 secondary parochial school while acting in the scope of his

- 8 properly attired while acting in the scope of his or her

- 10 <u>school entity or police department;</u>

- 12 (C) OFFICERS, EMPLOYEES, ETC., ENUMERATED.--THE OFFICERS,
- 13 AGENTS, EMPLOYEES AND OTHER PERSONS REFERRED TO IN SUBSECTION
- 14 (A) SHALL BE AS FOLLOWS:

- 16 (2) FIREFIGHTER, INCLUDING VOLUNTEER FIREFIGHTERS AND
- 17 SPECIAL FIRE POLICE.

- 19 (27) A TEACHING STAFF MEMBER, A SCHOOL BOARD MEMBER OR
- OTHER EMPLOYEE, INCLUDING A STUDENT EMPLOYEE, OF ANY
- 21 ELEMENTARY OR SECONDARY PUBLICLY FUNDED EDUCATIONAL
- 22 INSTITUTION, ANY ELEMENTARY OR SECONDARY PRIVATE SCHOOL
- 23 LICENSED BY THE DEPARTMENT OF EDUCATION OR ANY ELEMENTARY OR
- 24 SECONDARY PAROCHIAL SCHOOL WHILE ACTING IN THE SCOPE OF HIS
- 25 OR HER EMPLOYMENT OR BECAUSE OF HIS OR HER EMPLOYMENT
- 26 RELATIONSHIP TO THE SCHOOL, OR A CROSSING GUARD WHO IS
- 27 PROPERLY ATTIRED WHILE ACTING IN THE SCOPE OF HIS OR HER
- 28 OFFICIAL CAPACITY AS DESIGNATED BY A POLITICAL SUBDIVISION,
