AN ACT

- Amending Title 74 (Transportation) of the Pennsylvania
 Consolidated Statutes, proscribing indemnity agreements in
 motor carrier transportation contracts.

 The General Assembly of the Commonwealth of Pennsylvania
 hereby enacts as follows:
 Section 1. Title 74 of the Pennsylvania Consolidated

 Statutes is amended by adding a chapter to read:

- 11 8401. Definitions.
- 12 <u>8402</u>. <u>Indemnity provisions void</u>.
- 13 § 8401. Definitions.
- 14 The following words and phrases when used in this chapter
- 15 shall have the meanings given to them in this section unless the
- 16 context clearly indicates otherwise:

- 1 "Common carrier by motor vehicle." As defined in 66 Pa.C.S.
- 2 § 102 (relating to definitions).
- 3 "Contract carrier by motor vehicle." As defined in 66
- 4 Pa.C.S. § 2501(b) (relating to definitions).
- 5 "Indemnity provision." A provision which:
- 6 (1) is contained in, is collateral to or affects a motor
- 7 <u>carrier transportation contract; and</u>
- 8 (2) indemnifies or attempts to indemnify the promisee
- 9 <u>against liability for loss or damage resulting from</u>
- 10 intentional, reckless or negligent acts or omissions.
- 11 "Motor carrier." As defined in 66 Pa.C.S. § 102 (relating to
- 12 definitions).
- 13 "Motor carrier transportation contract." Any contract,
- 14 agreement or understanding covering any of the following:
- 15 (1) Transportation of property for compensation by a
- 16 motor carrier.
- 17 (2) Entrance on property by a motor carrier for the
- 18 purpose of loading, unloading or transporting property for
- 19 compensation.
- 20 (3) Service incidental to activity described in
- 21 paragraph (1) or (2). This paragraph includes storage of
- 22 property.
- 23 The term does not include the Uniform Intermodal Interchange and
- 24 Facilities Access Agreement administered by the Intermodal
- 25 Association of North America or other agreements providing for
- 26 the interchange, use or possession of intermodal chassis,
- 27 <u>containers or other intermodal equipment.</u>
- 28 "Promisee." A person that receives a promise under a motor
- 29 carrier transportation contract. The term includes any agent,
- 30 employee or independent contractor that is directly responsible

- 1 to the promisee. The term excludes a motor carrier.
- 2 § 8402. Indemnity provisions void.
- 3 (a) Public policy. -- The General Assembly finds and declares
- 4 that, except as set forth in subsection (c), indemnity
- 5 provisions are against the public policy of the Commonwealth.
- 6 (b) Effect.--Except as set forth in subsection (c), an
- 7 <u>indemnity provision is void.</u>
- 8 (c) Exception. -- This section shall not apply to a contract
- 9 or agreement which concerns or affects transportation involving
- 10 a railroad.
- 11 Section 2. The addition of 74 Pa.C.S. § 8402 shall apply to
- 12 contracts entered into or renewed on or after the effective date
- 13 of this section.
- 14 Section 3. This act shall take effect in 60 days.
