## AN ACT

- Designating U.S. Route 30 from its intersection with State Route 462 in West Manchester Township, York County, to the point
- where it meets the Susquehanna River in Hellam Township, York
- 4 County, as the Korean War Veterans Memorial Highway.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Korean War Veterans Memorial Highway.
- 8 (a) Findings. -- The General Assembly finds and declares as
- 9 follows:
- 10 (1) The Korean War was waged from June of 1950 to July
- of 1953 and ended with a negotiated armistice. Officially,
- 12 the United States' presence in Korea was a police action.
- 13 (2) One million five hundred thousand Americans served
- in the Korean War. Nearly 37,000 Americans died in the
- 15 conflict and 103,000 others were wounded. Approximately 8,000

- 1 Americans are still listed as missing in action.
- 2 (b) Designation.--U.S. Route 30 from its intersection with
- 3 State Route 462 in West Manchester Township, York County, to the
- 4 point where it meets the Susquehanna River in Hellam Township,
- 5 York County, is designated as the Korean War Veterans Memorial
- 6 Highway.
- 7 (c) Signs.—The Department of Transportation shall erect and
- 8 maintain appropriate signs displaying the name of the highway to
- 9 traffic in both directions.
- 10 Section 2. Effective date.
- 11 This act shall take effect in 60 days.
