## A RESOLUTION

- 1 Recognizing the month of March 2009 as "National Athletic
- 2 Training Month" in Pennsylvania.
- 3 WHEREAS, Quality health care is vital for individuals
- 4 involved in physical activity; and
- 5 WHEREAS, Certified athletic trainers have a long history of
- 6 providing quality health care for athletes and persons engaged
- 7 in physical activity based on specific tasks, knowledge and
- 8 skills acquired through nationally regulated educational
- 9 processes; and
- 10 WHEREAS, Athletic training involves prevention of injuries,
- 11 recognition, evaluation and aggressive treatment,
- 12 rehabilitation, health care administration, education, research
- 13 and quidance; and

- 1 WHEREAS, Athletic training was recognized by the American
- 2 Medical Association in 1990 as an allied health care profession;
- 3 and
- 4 WHEREAS, The National Athletic Trainers' Association
- 5 represents and supports the more than 30,000 members of the
- 6 athletic training profession employed in professional sports,
- 7 colleges and universities, high schools, clinics and hospitals,
- 8 corporate and industrial settings and the military; and
- 9 WHEREAS, Leading organizations have joined together to raise
- 10 public awareness of athletic training and to emphasize the
- 11 importance of quality health care for athletes and persons
- 12 engaged in physical activity, with the aim of improving health
- 13 care for athletes and physically active people and promoting
- 14 certified athletic trainers as allied health professionals;
