## A RESOLUTION

- 1 Recognizing the month of May 2010 as "Foster Care Month" in Pennsylvania.
- 3 WHEREAS, The family, a primary source of love, identity,
- 4 self-esteem and support, is the very foundation of our
- 5 communities and our Commonwealth; and
- 6 WHEREAS, In Pennsylvania there are approximately 20,000
- 7 children and youth in foster care every day; and
- 8 WHEREAS, Children and youth in foster care are provided a
- 9 safe, secure and stable home and a compassionate and nurturing
- 10 foster family; and
- 11 WHEREAS, Foster families open their homes and hearts to
- 12 children whose families are in crisis; and

- 1 WHEREAS, Foster families play a vital role in helping
- 2 children and families heal and reconnect and in preparing
- 3 children for successful adulthood; and
- 4 WHEREAS, Dedicated foster families frequently adopt foster
- 5 children, resulting in a greater need for more foster families;
- 6 and
- 7 WHEREAS, In this Commonwealth foster parents adopt more than
- 8 60% of the children in the child welfare system who have had
- 9 their goal changed to adoption; and
- 10 WHEREAS, Numerous individuals, public organizations and
- 11 private organizations are working to increase awareness of the
- 12 needs of children in foster care or leaving foster care and of
- 13 the enduring and valuable contribution of foster parents; and
- 14 WHEREAS, The foster care system is only as good as those
- 15 persons who choose to be part of it; therefore be it
- 16 RESOLVED, That the House of Representatives recognize the
- 17 month of May 2010 as "Foster Care Month" in Pennsylvania and
- 18 urge all citizens to volunteer their talents and energies on
- 19 behalf of children in foster care, foster parents and child
- 20 welfare professionals.
