## A RESOLUTION

- Designating May 15 through June 15, 2010, as "Tourette Syndrome Awareness Month" in Pennsylvania.
- 3 WHEREAS, An estimated three in every 1,000 children six to 17
- 4 years of age in the United States and this Commonwealth are
- 5 diagnosed with Tourette Syndrome, a neurobiological, genetic
- 6 condition which has no cure; and
- 7 WHEREAS, Tourette Syndrome is a lifelong developmental
- 8 disability that begins before a child reaches 18 years of age
- 9 and affects children and adults of all races and ethnicities;
- 10 and
- 11 WHEREAS, Individuals with Tourette Syndrome are affected by
- 12 tics which are involuntary, rapid, sudden movements or

- 1 vocalizations that occur repeatedly; and
- 2 WHEREAS, Individuals with Tourette Syndrome face periodic
- 3 changes in the nature and severity of their tics, as these
- 4 symptoms wax and wane and change without forewarning; and
- 5 WHEREAS, Individuals with Tourette Syndrome frequently have
- 6 co-occuring conditions that further complicate their care and
- 7 diagnosis, including attention deficit disorder, attention
- 8 deficit hyperactivity disorder, obsessive-compulsive disorder,
- 9 mood disorders, learning disabilities, handwriting difficulties,
- 10 executive function disorder and sensory processing disorder; and
- 11 WHEREAS, Individuals with Tourette Syndrome are frequently
- 12 misunderstood by their families, educators, the community and
- 13 even by medical professionals due to their ever-changing
- 14 symptoms which at times seem controllable; and
- WHEREAS, Tourette Syndrome has historically been
- 16 misinterpreted and considered to be a condition of emotional
- 17 disturbance instead of chemical biology; and
- 18 WHEREAS, Individuals with Tourette Syndrome are often teased
- 19 and not accepted by their peers and the general public; and
- 20 WHEREAS, Children with Tourette Syndrome are often
- 21 disciplined for manifestations of their disability by educators
- 22 who fail to understand the child's inability to control his or
- 23 her tics and that the child may be delayed in his or her
- 24 maturity and emotional responses; and
- 25 WHEREAS, Individuals with Tourette Syndrome face
- 26 discrimination from educators, friends, family, employers,
- 27 coworkers and the judicial system while dealing with their
- 28 unpredictable disorder and uncertain future; and
- 29 WHEREAS, Schools are required to make accommodations to
- 30 support their students with Tourette Syndrome to be successful

- 1 in their education program, but many schools often focus only on
- 2 the behavioral or emotional component of the disorder and fail
- 3 to notice learning disabilities, sensory integration needs,
- 4 handwriting issues and organizational issues as being related to
- 5 Tourette Syndrome; and
- 6 WHEREAS, Individuals with Tourette Syndrome are often very
- 7 intelligent and capable of great contributions to society when
- 8 given the proper support; and
- 9 WHEREAS, Employers are required under the Americans with
- 10 Disabilities Act to disregard disability in hiring or promotions
- 11 and to make accommodations to support their employees with
- 12 Tourette Syndrome so the employees can be successful in the
- 13 workplace and not be forced to file for disability; and
- 14 WHEREAS, Employers can benefit from that success, but many
- 15 employers often neglect to hire, promote and make these
- 16 accommodations for individuals with Tourette Syndrome; and
- 17 WHEREAS, The Pennsylvania Tourette Syndrome Alliance, Inc.,
- 18 has been established to promote awareness and provide support
- 19 and advocacy for individuals with Tourette Syndrome in this
- 20 Commonwealth; and
- 21 WHEREAS, Understanding this illness will help guarantee hope
- 22 for acceptance and a better future for people with Tourette
- 23 Syndrome; therefore be it
- 24 RESOLVED, That the House of Representatives designate May 15
- 25 through June 15, 2010, as "Tourette Syndrome Awareness Month" in
- 26 Pennsylvania and urge all citizens to support the need for
- 27 awareness and education regarding Tourette Syndrome in order to
- 28 assist those individuals and families who deal with this
- 29 neurobiological syndrome every day of their lives.
