Definitions. -- As used in this act: * * * 12 13 "Department" means the Department of Community [Affairs] 14 and Economic Development of the Commonwealth of Pennsylvania. * * * 15 (4.1) "Industrialized/commercial modular building" means a 16 17 structure designed for commercial occupancy, and classified

- 5 processes of manufacture cannot be inspected at the site without
- 6 <u>disassembly</u>, <u>damage or destruction</u>. The term does not include
- 7 <u>industrialized housing as defined in 12 Pa. Code § 145.1</u>
- 8 (relating to definitions) or manufactured home, as defined in
- 9 <u>section 5402(6) of the National Manufactured Housing</u>
- 10 Construction and Safety Standards Act of 1974 (Public Law 93-383
- 11 <u>42 U.S.C. § 5401 et seq.).</u>
- 12 (4.2) "Industrialized/commercial building module" means a
- 13 <u>closed wall structure or substantial part of a closed wall</u>
- 14 structure incorporating one or more rooms used as habitable,
- 15 occupiable or mechanical/equipment space, which is fabricated in
- 16 a manufacturing facility to be separately transported to the
- 17 building site that cannot be inspected at the site without
- 18 disassembly. This term also includes industrialized/commercial
- 19 <u>building components that are subsystems or assemblies, or other</u>
- 20 systems of closed construction designed for use in or as a part
- 21 of an industrialized commercial building.

- 25 Section 4. Regulations, Insignia of Certification

- 27 <u>(j) The department is authorized to enter into a multistate</u>
- 28 agreement for the purpose of regulating the construction of
- 29 <u>components of industrialized/commercial modular buildings. The</u>
- 30 department shall adopt regulations to administer the program.

- 1 Modules of industrialized/commercial modular buildings that are
- 2 <u>certified under the program established pursuant to this</u>
- 3 <u>subsection shall be deemed to meet the requirements of the act</u>
- 4 <u>of November 10, 1999 (P.L.491, No.45), known as the</u>
- 5 <u>"Pennsylvania Construction Code Act."</u>
- 6 Section 3. This act shall take effect immediately.
