## AN ACT

- 1 Making an appropriation to Salus University, Philadelphia.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. The sum of \$378,000 is hereby appropriated to
- 5 Salus University, Philadelphia, for the fiscal year July 1,
- 6 2009, to June 30, 2010, for instruction.
- 7 Section 2. Payments to Salus University on account of the
- 8 appropriation provided in section 1 shall be made quarterly by
- 9 the Secretary of Education on the basis of costs during the
- 10 fiscal year and shall be conditioned on continuing authority for
- 11 inclusion on the Board of Trustees of Salus University of a
- 12 minimum of five persons who are not elected officials and who
- 13 are appointed by the Governor, the President pro tempore of the
- 14 Senate, the Minority Leader of the Senate, the Speaker of the
- 15 House of Representatives and the Minority Leader of the House of
- 16 Representatives for terms of office coterminous with that of the
- 17 respective appointing authority; and shall be further
- 18 conditioned on these appointees receiving full voting rights as

- 1 members of the board of trustees.
- 2 Section 3. Salus University shall provide full, complete and
- 3 accurate information as may be required by the Department of
- 4 Education or the chairman or the minority chairman of the
- 5 Appropriations Committee of the Senate or the chairman or the
- 6 minority chairman of the Appropriations Committee of the House
- 7 of Representatives.
- 8 Section 4. Salus University shall report its revenues and
- 9 expenditures and present its financial statements in accordance
- 10 with generally accepted accounting principles and procedures for
- 11 educational institutions as set forth in the "Higher Education
- 12 Finance Manual (1975)" and the "Commonwealth of Pennsylvania
- 13 Budget Instructions for the State System of Higher Education,
- 14 State-Related Universities and Non-State-Related Colleges and
- 15 Universities."
- 16 Section 5. The trustees of Salus University shall report on
- 17 forms provided by the Department of Education to both the
- 18 chairman and minority chairman of the Appropriations Committee
- 19 of the Senate and the chairman and minority chairman of the
- 20 Appropriations Committee of the House of Representatives by
- 21 September 30, 2010, on how State-appropriated funds were
- 22 expended for fiscal year 2009-2010 to reduce the costs to
- 23 Pennsylvania resident students or to provide services to
- 24 Pennsylvania residents.
- 25 Section 6. This act shall take effect immediately.
