AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," providing for State aid for fiscal year 2010-2011. 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. State aid for fiscal year 2010-2011. 13 (a) Distribution. -- Funds appropriated for libraries shall be 14 distributed to each library under the following formula: 15 (1) Divide the sum of the amount of funding that the library received in fiscal year 2009-2010 under section 1722-16 17 J(14) of the act of April 9, 1929 (P.L.343, No.176), known as 18 The Fiscal Code, by the total State aid subsidy for fiscal

(2) Multiply the quotient under subparagraph (i) by the

- 2 (b) Remaining funds. -- Following distribution of funds
- 3 appropriated for State aid to libraries, any remaining funds may
- 4 be distributed at the discretion of the State Librarian.
- 5 (c) Waiver.--If funds appropriated for State aid to
- 6 libraries in fiscal year 2010-2011 are less than funds
- 7 appropriated in fiscal year 2002-2003, the State Librarian may
- 8 <u>waive standards as prescribed under section 103 of the act of</u>
- 9 <u>June 14, 1961 (P.L.324, No.188), known as The Library Code,</u>
- 10 relating to hours of operation, continuing professional
- 11 <u>development</u>, <u>collections</u>, <u>expenditures</u> and <u>other aspects of</u>
- 12 <u>library operation</u>.
- 13 <u>(d) Local share.--The following shall apply:</u>
- 14 (1) Each library system receiving State aid under this
- 15 <u>section may distribute the local library share of that aid in</u>
- 16 <u>a manner as determined by the board of directors of the</u>
- 17 library system.
- 18 (2) Paragraph (1) shall not apply to a library system
- 19 operating in a county of the second class.
- 20 Section 2. This act shall take effect July 1, 2010, or
- 21 immediately, whichever is later.
