AN ACT

- 1 Regulating lead management and remediation at firing ranges.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Freedom to
- 6 Shoot Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Commission." The Pennsylvania Game Commission.
- 12 "Director." The director of the commission.
- 13 "Federal standard." The Best Management Practices for Lead
- 14 at Outdoor Shooting Ranges (June 2005), established by the
- 15 Environmental Protection Agency.
- 16 "Task force." The Task Force on Lead Management and
- 17 Remediation at Firing Ranges established in section 3.

- 1 Section 3. Task force.
- 2 (a) Establishment. -- The Task Force on Lead Management and
- 3 Remediation at Firing Ranges is established.
- 4 (b) Membership. -- The task force shall consist of the
- 5 following individuals:
- 6 (1) The Secretary of Conservation and Natural Resources
- 7 or a designee.
- 8 (2) The Secretary of Environmental Protection or a
- 9 designee.
- 10 (3) The Secretary of Health or a designee.
- 11 (4) A representative of the Amateur Trapshooting
- 12 Association.
- 13 (5) A representative of the Pennsylvania Federation of
- 14 Sportsmen's Club, Inc.
- 15 (6) A representative of the Pennsylvania State
- 16 Sportsmen's Association.
- 17 (7) The director.
- 18 (c) Organization.--
- 19 (1) The director shall serve as chair.
- 20 (2) Four members constitute a quorum.
- 21 (d) Functions. -- The task force has the following functions:
- 22 (1) To study lead management and remediation at firing
- 23 ranges.
- 24 (2) To recommend to the commission, within six months of
- 25 the effective date of this section, regulations for lead
- 26 management and remediation at firing ranges which can be
- applied evenly and fairly throughout this Commonwealth.
- 28 Section 4. Commission.
- 29 (a) Regulations. -- The commission shall promulgate
- 30 regulations for lead management and remediation at firing

- 1 ranges.
- 2 (b) Time. -- The commission shall initiate the regulatory
- 3 process on the earlier of:
- 4 (1) receipt of the recommendation under section 3(d)(2);
- 5 or
- 6 (2) six months after the effective date of section 3.
- 7 Section 5. Primacy.
- 8 (a) Legal principles. -- The only law of this Commonwealth for
- 9 the regulation of lead management and remediation at firing
- 10 ranges is:
- 11 (1) before the effective date of regulations under
- section 4, the Federal standard; and
- 13 (2) on and after the effective date of regulations under
- section 4, the regulations under section 4.
- 15 (b) Commonwealth agencies.--Commonwealth agencies shall
- 16 apply the legal principles under subsection (a).
- 17 (c) Firing ranges.--
- 18 (1) Except as set forth in paragraph (2), shooting at a
- firing range may not be curtailed nor impeded by a
- 20 Commonwealth agency.
- 21 (2) Shooting at a firing range may be curtailed or
- impeded by a Commonwealth agency if any of the following
- 23 apply:
- 24 (i) The management of the firing range consents in
- 25 writing to the action.
- 26 (ii) The commission consents to the action because
- of scientific proof that the action is necessary to avoid
- environmental degradation which is beyond remediation.
- 29 Section 20. Effective date.
- This act shall take effect immediately.
