1 2 3	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, further providing for failure to comply with registration of sexual offenders requirements.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Section 4915(a) and (c) of Title 18 of the
7	Pennsylvania Consolidated Statutes are amended to read:
8	§ 4915. Failure to comply with registration of sexual offenders
9	requirements.
10	(a) Offense definedAn individual who is subject to
11	registration under 42 Pa.C.S. § 9795.1(a) (relating to
12	registration) or an individual who is subject to registration
13	under 42 Pa.C.S. § [9795.1(b)(1), (2) or (3)] <u>9795.1(b)</u> commits
14	an offense if he knowingly fails to:

(1) register with the Pennsylvania State Police as
 required under 42 Pa.C.S. § 9795.2 (relating to registration
 procedures and applicability);

4 (2) verify his address or be photographed as required
5 under 42 Pa.C.S. § 9796 (relating to verification of
6 residence); or

7 (3) provide accurate information when registering under
8 42 Pa.C.S. § 9795.2 or verifying an address under 42 Pa.C.S.
9 § 9796.

11 (c) Grading for sexually violent predators and others with 12 lifetime registration.--

13 (2) Except as set forth in paragraph (3), an individual
14 subject to registration under 42 Pa.C.S. § [9795.1(b)(1), (2)
15 or (3)] <u>9795.1(b)</u> who commits a violation of subsection (a)
16 (1) or (2) commits a felony of the second degree.

17 (3) An individual subject to registration under 42
18 Pa.C.S. § [9795.1(b)(1), (2) or (3)] <u>9795.1(b)</u> who commits a
19 violation of subsection (a)(1) or (2) and who has previously
20 been convicted of an offense under subsection (a)(1) or (2)
21 or a similar offense commits a felony of the first degree.

(4) An individual subject to registration under 42
Pa.C.S. § [9795.1(b)(1), (2) or (3)] <u>9795.1(b)</u> who violates
subsection (a)(3) commits a felony of the first degree.
