## AN ACT

- Amending Title 62 (Procurement) of the Pennsylvania Consolidated Statutes, IN GENERAL PROVISIONS, providing for public access
- 3 to procurement information.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 62 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 106.1. Public access to procurement information.
- 9 (a) Access.--Information concerning a procurement shall be
- 10 made public, consistent with the act of February 14, 2008
- 11 (P.L.6, No.3), known as the Right-to-Know Law.
- 12 (b) Access for noncompetitive contracts.--Except as provided  $\leftarrow$
- 13 <u>under subsection (c), if IF a procurement is to be made under</u>
- 14 section 513 (relating to competitive sealed proposals), 515
- 15 (relating to sole source procurement), 517 (relating to multiple

- 1 <u>awards</u>), 518 (relating to competitive selection procedures for
- 2 <u>certain services</u>), 519 (relating to selection procedure for
- 3 insurance and notary bonds) or 905 (relating to procurement of
- 4 <u>design professional services</u>), five business days prior to
- 5 execution by the contracting official the purchasing agency
- 6 shall post the proposed contract AND ANY WRITTEN DETERMINATION
- 7 MADE BY THE CONTRACTING OFFICER WHICH IS RELATED TO THE CONTRACT
- 8 on its Internet website.
- 9 (c) Exception. -- The provisions of subsection (b) shall not
- 10 apply to a procurement under section 516 (relating to emergency
- 11 procurement).
- 12 Section 2. This act shall take effect in 60 days.
