AN ACT

Amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, further providing for the composition of the State Veterans' Commission. 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 1702(b) of Title 51 of the Pennsylvania 6 Consolidated Statutes is amended to read: § 1702. State Veterans' Commission. 9 10 (b) Composition. -- The commission shall be composed of: The Adjutant General, ex officio, or his designee. 11 (1)12 (2) The State commander, commandant or head, or his 13 designee, of each of the following named veterans' 14 organizations: The American Legion. 15 (i) 16 (ii) AMVETS.
