AN ACT

- 1 Designating State Route 997 within the limits of the Borough of
- Mont Alto, Franklin County, as the Sgt. Edward W. Shaffer
- 3 Memorial Highway.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sgt. Edward W. Shaffer Memorial Highway.
- 7 (a) Findings. -- The General Assembly finds and declares as
- 8 follows:
- 9 (1) Sqt. Edward W. Shaffer from Franklin County died
- December 27, 2006, at 23 years of age, from severe burn
- injuries sustained during combat by a roadside bomb on
- 12 November 13, 2006, while serving in Iraq. He was assigned to
- 13 the 1st Battalion, 36th Infantry Regiment, 1st Brigade Combat
- 14 Team, 1st Armored Division during Operation Iraqi Freedom. He

- 1 was the first soldier from Franklin County to die in the war.
- 2 (2) Sgt. Shaffer was a 2002 graduate of Waynesboro Area
- 3 Senior High School. He enlisted in the Army in 2003, served
- 4 in Germany and Kuwait before going to Iraq and served in Iraq
- 5 for approximately eight months before the explosion.
- 6 (3) Sgt. Shaffer was a gunner in a Bradley tank during
- 7 operations in Ramadi, the capital of Anbar, about 70 miles
- 8 west of Baghdad when the roadside bomb exploded.
- 9 (4) Sgt. Shaffer was awarded two Purple Heart medals
- during his service with the United States Army.
- 11 (b) Designation.--State Route 997 within the limits of the
- 12 Borough of Mont Alto, Franklin County, is hereby designated as
- 13 the Sgt. Edward W. Shaffer Memorial Highway.
- 14 (c) Signs. -- The Department of Transportation shall erect and
- 15 maintain appropriate signs displaying the name of the highway
- 16 designated under subsection (b) to traffic in both directions.
- 17 Section 2. Effective date.
- 18 This act shall take effect in 60 days.
