- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, further providing for definitions; and providing
- for regulation and operation of neighborhood electric
- 4 vehicles.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The definition of "motor vehicle" in section 102
- 8 of Title 75 of the Pennsylvania Consolidated Statutes is amended
- 9 and the section is amended by adding a definition to read:
- 10 § 102. Definitions.
- 11 Subject to additional definitions contained in subsequent
- 12 provisions of this title which are applicable to specific
- 13 provisions of this title, the following words and phrases when
- 14 used in this title shall have, unless the context clearly
- 15 indicates otherwise, the meanings given to them in this section:
- 16 * * *
- 17 "Motor vehicle." A vehicle which is self-propelled except an

- 1 electric personal assistive mobility device, a neighborhood
- 2 <u>electric vehicle</u> or a vehicle which is propelled solely by human
- 3 power.

- 5 "Neighborhood electric vehicle." A four-wheeled electric
- 6 <u>vehicle that has a maximum design speed of not less than 20</u>
- 7 miles per hour and of not more than 25 miles per hour and that
- 8 complies with the Federal safety standards established in 49 CFR
- 9 <u>571.500 (relating to standard no. 500; low-speed vehicles).</u>

- 11 Section 2. Chapter 35 of Title 75 is amended by adding a
- 12 subchapter to read:

- 16 <u>3591. Scope of subchapter.</u>
- 17 3592. Required equipment.
- 18 3593. Operation on certain highways or roadways.
- 19 3594. Certificate of title and registration required.
- 20 <u>3595. License and financial responsibility required.</u>
- 21 3596. Exemption.
- 22 § 3591. Scope of subchapter.
- This subchapter applies to the operation of neighborhood
- 24 electric vehicles on certain highways or roadways in this
- 25 Commonwealth.
- 26 § 3592. Required equipment.
- 27 <u>A neighborhood electric vehicle shall be equipped in</u>
- 28 accordance with 49 CFR 571.500 (relating to standard no. 500;
- 29 <u>low-speed vehicles</u>). This equipment shall include the following:
- 30 <u>(1) Headlamps.</u>

- 1 (2) Stop lamps.
- 2 <u>(3) Turn signal lamps.</u>
- 3 (4) Reflex reflectors.
- 4 <u>(5) Parking brake.</u>
- 5 (6) Rearview exterior mirror.
- 6 (7) Rearview interior mirror.
- 7 <u>(8) Windshield.</u>
- 8 <u>(9) Windshield wiper.</u>
- 9 <u>(10) Speedometer.</u>
- 10 (11) Odometer.
- 11 (12) Braking for each wheel.
- 12 (13) Seat belts.
- 13 <u>(14) Vehicle identification number.</u>
- 14 (15) Other equipment as required by Federal regulations.
- 15 § 3593. Operation on certain highways or roadways.
- 16 <u>A neighborhood electric vehicle may be operated on any</u>
- 17 highway or roadway where the posted speed limit is 35 miles per
- 18 hour or less. This section does not prohibit a person from
- 19 operating a neighborhood electric vehicle across an intersection
- 20 where the highway or roadway has a posted speed limit of more
- 21 than 35 miles per hour.
- 22 § 3594. Certificate of title and registration required.
- 23 A neighborhood electric vehicle shall be properly titled and
- 24 registered with the department as required by Chapters 11
- 25 (relating to certificate of title and security interests) and 13
- 26 (relating to registration of vehicles).
- 27 § 3595. License and financial responsibility required.
- 28 An operator of a neighborhood electric vehicle must have a
- 29 <u>valid driver's license and maintain financial responsibility as</u>
- 30 required by Chapters 15 (relating to licensing of drivers) and

- 1 17 (relating to financial responsibility).
- 2 <u>§ 3596. Exemption.</u>
- 3 A neighborhood electric vehicle shall be exempt from any
- 4 emissions testing required under this title or other law.
- 5 Section 3. This act shall take effect in 60 days.
