AN ACT

- 1 Providing for municipal regulation of the deposit, disposal or
- land application of biosolid material; and requiring a public
- 3 referendum under certain circumstances.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Biosolid
- 8 Material Municipal Regulation Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Affected municipality." A municipality in which biosolid
- 14 material is intended to be deposited, disposed of or applied to
- 15 land or that would be directly affected by the deposition,
- 16 disposal of or application to land of biosolids material in the
- 17 municipality.
- 18 "Biosolid material." Liquid or solid sludges and other

- 1 residues from a municipal sewage collection and treatment
- 2 system; and liquid or solid sludges and other residues from
- 3 septic and holding tank pumpings from commercial, institutional
- 4 or residential establishments. The term includes materials
- 5 derived from sewage sludge. The term does not include ash
- 6 generated during the firing of sewage sludge in a sewage sludge
- 7 incinerator, grit and screenings generated during preliminary
- 8 treatment of sewage sludge at a municipal sewage collection and
- 9 treatment system or grit, screenings and nonorganic objects from
- 10 septic and holding tank pumpings.
- 11 "Department." The Department of Environmental Protection of
- 12 the Commonwealth.
- "Deposit, disposal or land application site." The physical
- 14 location where biosolid material is intended to be deposited,
- 15 disposed or applied in an affected municipality.
- 16 "Permit." A document issued by the Department of
- 17 Environmental Protection that grants a person, party,
- 18 corporation or governmental entity the authorization to deposit,
- 19 dispose or apply biosolid material or any composition containing
- 20 biosolid material in a municipality.
- 21 "Permit application." A request or petition to the
- 22 Department of Environmental Protection seeking authorization by
- 23 a person, party, corporation or governmental entity to deposit,
- 24 dispose or apply biosolid material or any composition containing
- 25 biosolid material in a municipality.
- 26 Section 3. Biosolid material ordinances.
- 27 (a) General rule. -- Subject to the provisions of subsections
- 28 (b) and (c), a municipality may adopt and enforce ordinances
- 29 regulating the deposit, testing, disposal or land application of
- 30 biosolid material.

- 1 (b) Relationship to other law. -- A municipal ordinance
- 2 regulating the deposit, disposal or land application of biosolid
- 3 material must be at least as stringent as the requirements of
- 4 the act of July 7, 1980 (P.L.380, No.97), known as the Solid
- 5 Waste Management Act, and the regulations promulgated under that
- 6 act.
- 7 (c) Biosolid testing. -- A municipality may adopt an ordinance
- 8 or resolution authorizing the municipality to conduct tests of
- 9 land for the deposits of the biosolid material, for the biosolid
- 10 material itself, or both. The expense of the tests must be paid
- 11 by:
- 12 (1) the entity that applied the biosolid material;
- 13 (2) the owner of the land; or
- 14 (3) the transporter of the biosolid material.
- 15 Upon written complaint of any person, the department may enter
- 16 upon any land in this Commonwealth and conduct tests of the land
- 17 for the application of biosolid material without prior notice to
- 18 the owner of the land.
- 19 Section 4. Municipal veto.
- In addition to the requirements of the act of July 7, 1980
- 21 (P.L.380, No.97), known as the Solid Waste Management Act, a
- 22 municipality may veto, provided that the provisions of section 5
- 23 are satisfied, a permit application approved by the department
- 24 for the deposit, disposal or land application of biosolid
- 25 material.
- 26 Section 5. Existing permits.
- 27 Any permit issued by the department between January 1, 2010,
- 28 and the effective date of this section that authorizes the
- 29 deposit, disposal or land application of biosolid material is
- 30 hereby declared null and void.

- 1 Section 6. Effective date.
- 2 This act shall take effect in 60 days.
