AN ACT

- 1 Designating a portion of State Route 955 in Lawrence Park
- 2 Township, Erie County, as the Michael D. Crotty Memorial
- 3 Parkway.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Michael D. Crotty Memorial Parkway.
- 7 (a) Findings.--The General Assembly finds and declares as
- 8 follows:
- 9 (1) Michael David Crotty was born in Erie, Pennsylvania,
- on April 14, 1983, and graduated from Iroquois High School in
- 11 2001.
- 12 (2) Michael D. Crotty served his county with honor and
- distinction as a member of the United States Air Force, and
- 14 also served as a member of the Chugiak Volunteer Fire and
- 15 Rescue Department while stationed at Elmendorf Air Force Base

- 1 in Anchorage, Alaska.
- 2 (3) Michael D. Crotty returned home to Lawrence Park
- 3 Township, Erie County, after being honorably discharged in
- 4 August 2007, at which time he was promoted to the rank of
- 5 deputy chief of the Lawrence Park Volunteer Fire Department.
- 6 (4) Michael D. Crotty was tested and named as a
- 7 firefighter for the City of Erie, Bureau of Fire, and was
- 8 assigned to Engine Company No. 6, Third Platoon.
- 9 (5) Michael D. Crotty passed away on April 8, 2008,
- while in performance of firefighting duties, at 24 years of
- 11 age.
- 12 (b) Designation. -- That portion of State Route 955 from East
- 13 Lake Road to Nagle Road in Lawrence Park Township, Erie County,
- 14 is hereby designated as the Michael D. Crotty Memorial Parkway.
- 15 (c) Signs. -- The Department of Transportation shall erect and
- 16 maintain appropriate signs to indicate the designation under
- 17 subsection (b) to traffic in both directions.
- 18 Section 2. Effective date.
- 19 This act shall take effect in 60 days.
