## AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, providing for a special license plate for
- recipients of the Silver Star, Bronze Star and Bronze Star
- 4 for Valor.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 75 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding sections to read:
- 9 § 1366. Special plates for recipients of Silver Star.
- 10 Upon application of any person who is a recipient of the
- 11 Silver Star, accompanied by a fee of \$10 which shall be in
- 12 addition to the annual registration fee and by such
- 13 <u>documentation as the department shall require, the department</u>
- 14 shall issue to the person a special registration plate

- 1 <u>designating the vehicle so licensed as belonging to a person who</u>
- 2 <u>is a recipient of the Silver Star. The special registration</u>
- 3 plate may be used only on a passenger car or truck with a
- 4 registered gross weight of not more than 10,000 pounds.
- 5 § 1367. Special plates for recipients of Bronze Star.
- 6 Upon application of any person who is a recipient of the
- 7 Bronze Star, accompanied by a fee of \$20 which shall be in
- 8 addition to the annual registration fee and by such
- 9 documentation as the department shall require, the department
- 10 shall issue to the person a special registration plate
- 11 <u>designating the vehicle so licensed as belonging to a person who</u>
- 12 <u>is a recipient of the Bronze Star. The special registration</u>
- 13 plate may be used only on a passenger car or truck with a
- 14 registered gross weight of not more than 10,000 pounds.
- 15 § 1368. Special plates for recipient of Bronze Star for Valor.
- 16 Upon application of any person who is a recipient of the
- 17 Bronze Star for Valor, accompanied by a fee of \$10 which shall
- 18 be in addition to the annual registration fee and by such
- 19 documentation as the department shall require, the department
- 20 shall issue to the person a special registration plate
- 21 designating the vehicle so licensed as belonging to a person who
- 22 is a recipient of the Bronze Star for Valor. The special
- 23 registration plate may be used only on a passenger car or truck
- 24 with a registered gross weight of not more than 10,000 pounds.
- 25 Section 2. This act shall take effect in 60 days.
